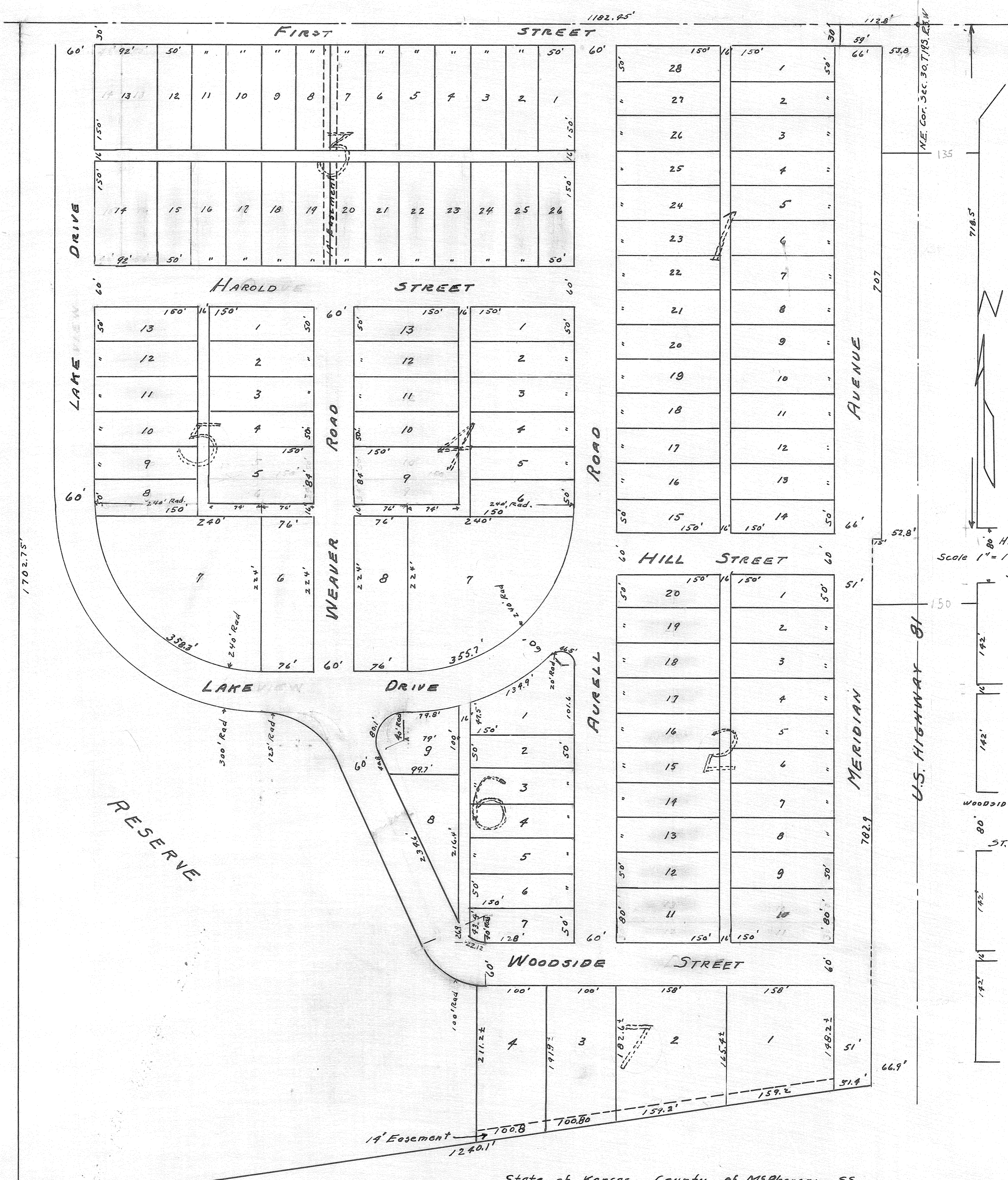


AURELL'S 44" SUBDIVISION

OF

PART OF NE 1/4 OF SEC. 30, T.19.S., R.3.W., 6TH P.M.



KNOW ALL MEN BY THESE PRESENTS, That Harold F. Aurell and Madge L. Aurell, his wife, owners and proprietors of the lands hereinafter described, have caused said lands to be surveyed and platted under the name of Aurell's Subdivision of part of the Northeast Quarter of Section 30, Township 19, South, Range 3, West in McPherson County, Kansas, and have caused the same to be subdivided into blocks, lots, streets, alleys and easements as shown on the accompanying plat to the public use.

DESCRIPTION. Part of the Northeast Quarter (NE 1/4) of Section Thirty (30), Township Nineteen (19) South, Range Three (3) West of the 6th P.M., more particularly described as follows, to-wit: Beginning at a point 112.8 feet west of the northeast corner of Section 30, Township 19, South, Range 3, West of the 6th P.M., thence west on the north line of said Section 30 a distance of 1182.45 feet, thence south 1702.75 feet to the north line of the Atchison Topeka and Santa Fe Railway Right of way, thence easterly along the north line of said railway right of way a distance of 1240.1 feet to a point 66.9 feet west of the east line of said Section 30, thence north 782.9 feet, thence east 15 feet to a point 73.7 feet south and 52.8 feet west of said northeast corner of said Section 30, thence north 707 feet to a point 53.8 feet west of the east line of said Section 30, thence west 59 feet, thence north 30 feet to the place of beginning.
