


# MAP OF BELLOWS ADDITION TO LINDSBORG KAN.



Know all men by these Presents: That E. S. Bellows, being the owner and proprietor of a tract of land, located in the North West Quarter of Section Sixteen (16) Township Seventeen (17) South, Range Three (3) West of the 6th P.M. in McPherson County, Kansas; have caused the said tract to be surveyed and plotted as and for an addition to Lindsborg, Kansas. The said tract located as above mentioned is more fully described within the following metes and bounds to wit:— Commencing at the South West corner of said Quarter Section and thence running North along the West line of said 1/4 Section nine hundred and ninety one (991) feet to a stone; thence East and parallel with the North line of said 1/4 Section One thousand eight hundred and seventy (1870) feet; thence South and parallel with the West line of said 1/4 Section nine hundred eighty four and eight tenths (984.8) feet to the South line of said 1/4 Section; thence West along the South line of said 1/4 Section One thousand eight hundred and seventy (1870) feet to the place of beginning— containing Forty-two and eight hundredths (42.18) acres.

I further publish and declare that the name of said Addition is Bellows Addition to Lindsborg, Kansas, and said addition is divided into Blocks, lots, streets and alleys as shown on the map herewith attached. The Blocks are denominated by figures in the natural sequence of numbers and are subdivided into lots which are further designated in a similar manner as shown on the map herewith. The dimensions of lots, streets and alleys are as marked on the map herewith in figures representing feet and tenths of a foot and all wedge shaped or irregular lots not so marked are subject to measurement. I further publish and declare that all grounds in said addition intended for Public Purposes, such as streets and alleys are as shown on the map herewith attached, and their names, courses and widths marked thereon.
