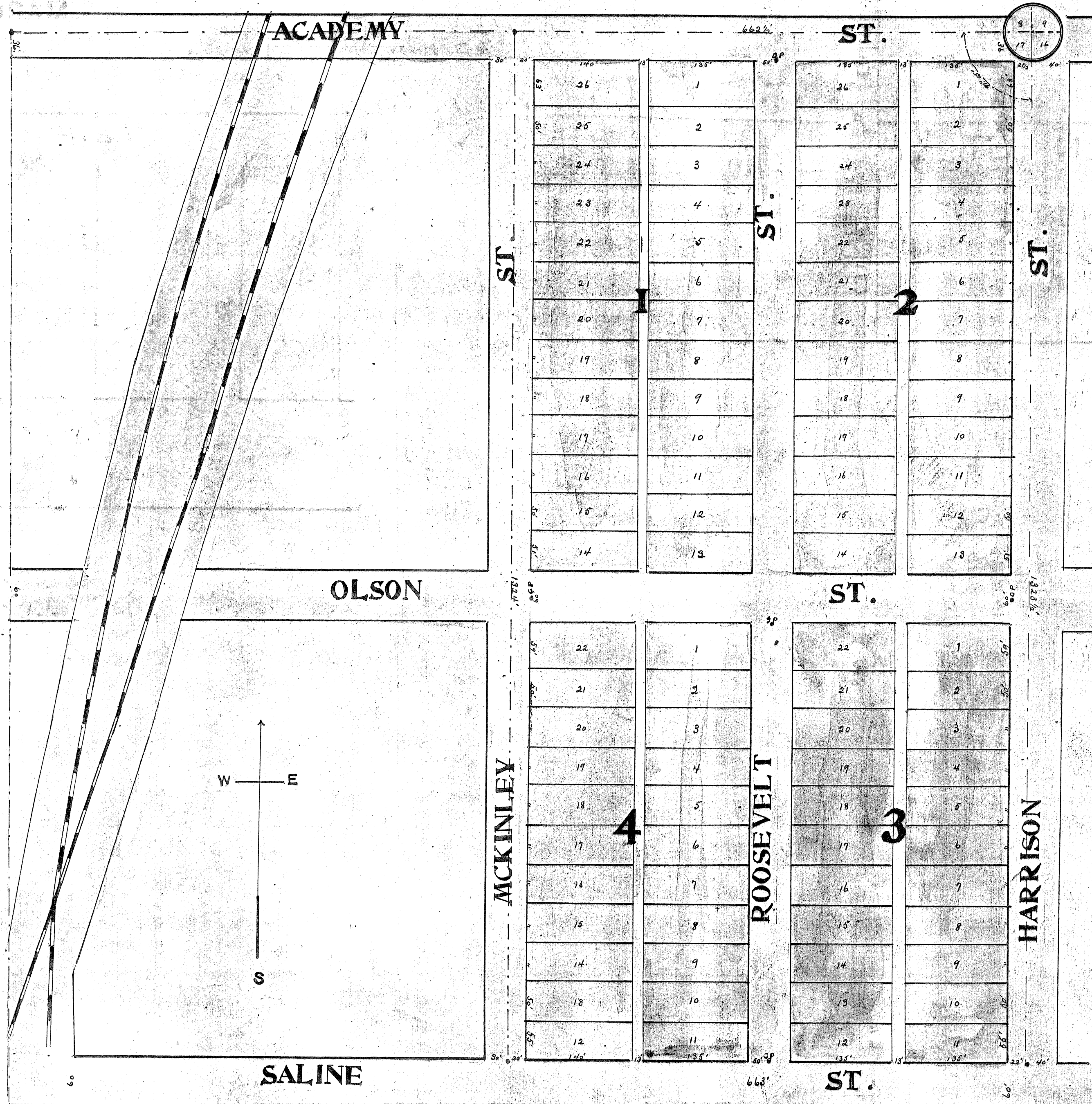


BETHANY ADDITION

This is to certify that J. H. A. Rowland, County Surveyor of McPherson County, Kansas, have surveyed and platted Bethany Addition to Lindsborg, Kansas, and that said Addition is situate on the East half of the North East Quarter of the North East Quarter of Section Seventeen (17) Town Seventeen (17) South and of Range Three (3) West of the Sixth P. M. and that its bounds are as follows: Beginning at the corner common to Sections 8, 9, 16 and 17 in Town 17 South and of Range 3 West, thence West on Section line 662 1/2 feet, thence South 1324 feet, thence East to Section line 663 feet, thence North on Section line 1323 1/2 feet and to the place of beginning. Said Addition is divided into Lots, Blocks, Streets and Alleys as is shown on the foregoing plat. Points marked "C. P." in center of Olson and Roosevelt Streets have one and one fourth inch gas pipe driven in center of Street and in line with the respective Block corners.
