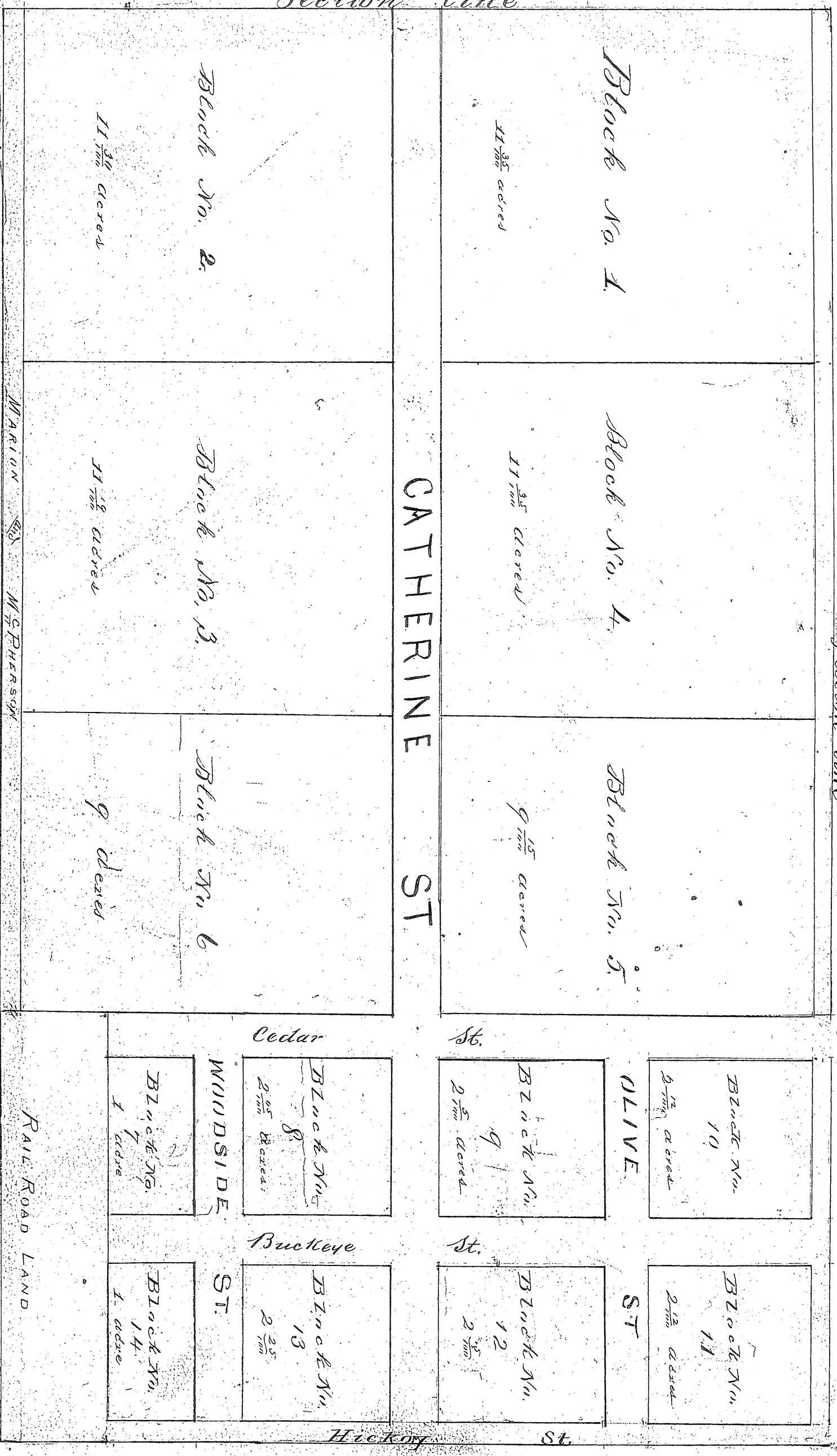


BREWERS SUBDIVISION
