

SUPPLEMENTARY MAP OF LINDSBORG KANSAS

Scale 200 Feet to 1 inch.

This is to certify that J. F. Cole, Deputy County Surveyor of McPherson County, Kansas, has surveyed and platted all of the original City of Lindsborg, Kansas, and the following named additions thereto, Pearson Addition, Church Addition and West Addition according to the original plat of same now upon record in the office of the Register of Deeds in and for McPherson County, Kansas. No change is made in the course or width of streets, except South Street which is made 20 feet wide. All alleys are reduced from 40 to 20 feet and the surplus placed in the blocks, except the alley between main and Washington from State to Grant Street, which is made 50 feet wide.

All streets, alleys, lots and blocks, are shown and designated on the accompanying plat. The length and width of lots and the width of all streets and alleys bearing shown in figures. Done by order of the City Council of the City of Lindsborg, Kansas. Witness my hand this 16th day of May A.D. 1887.

Cole, deputy county surveyor, be and the same is hereby approved and adopted as the official Supplementary Plat of the City of Lindsborg, Kansas, and is hereby ordered recorded in the office of the Register of Deeds in and for McPherson County, State of Kansas.

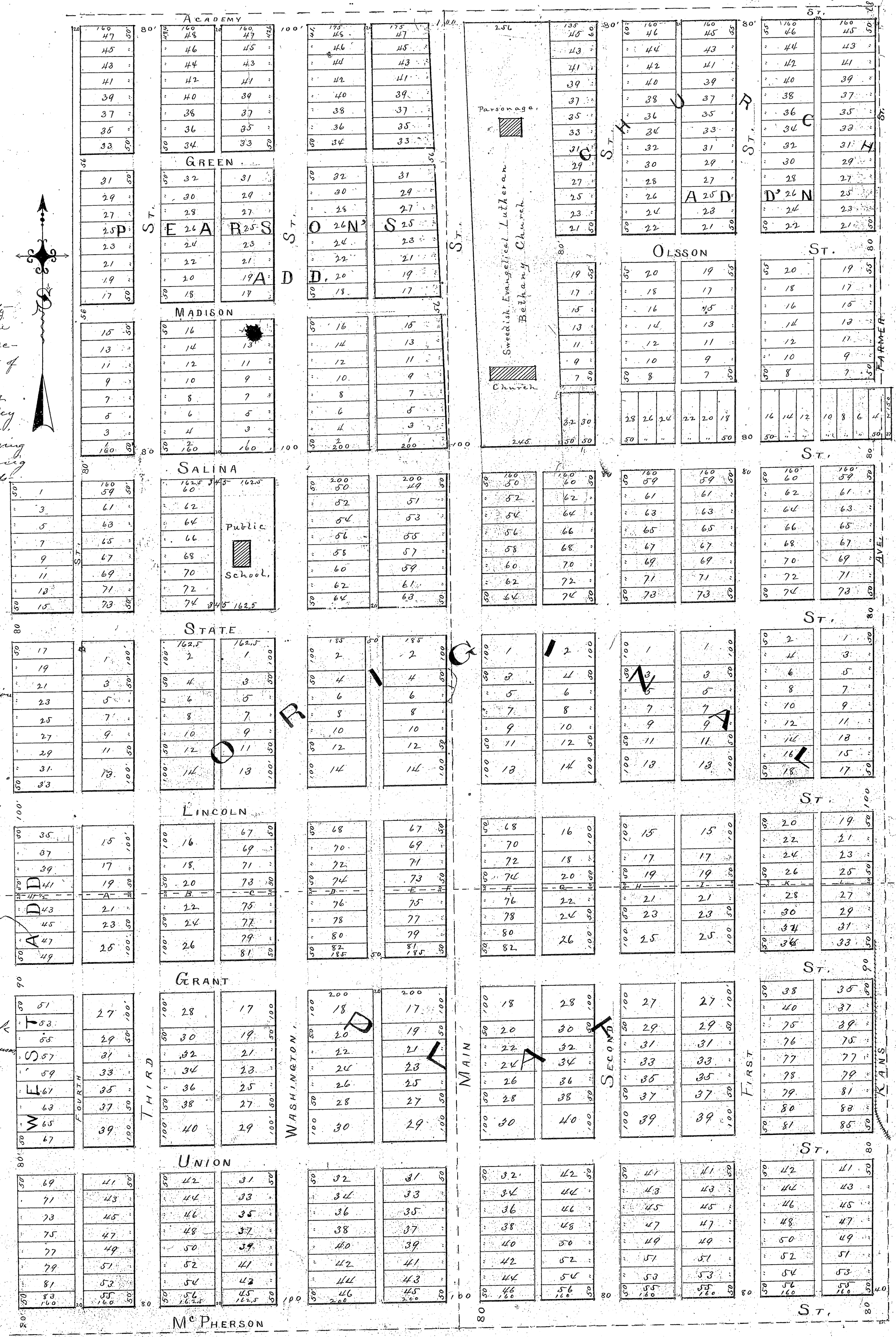
