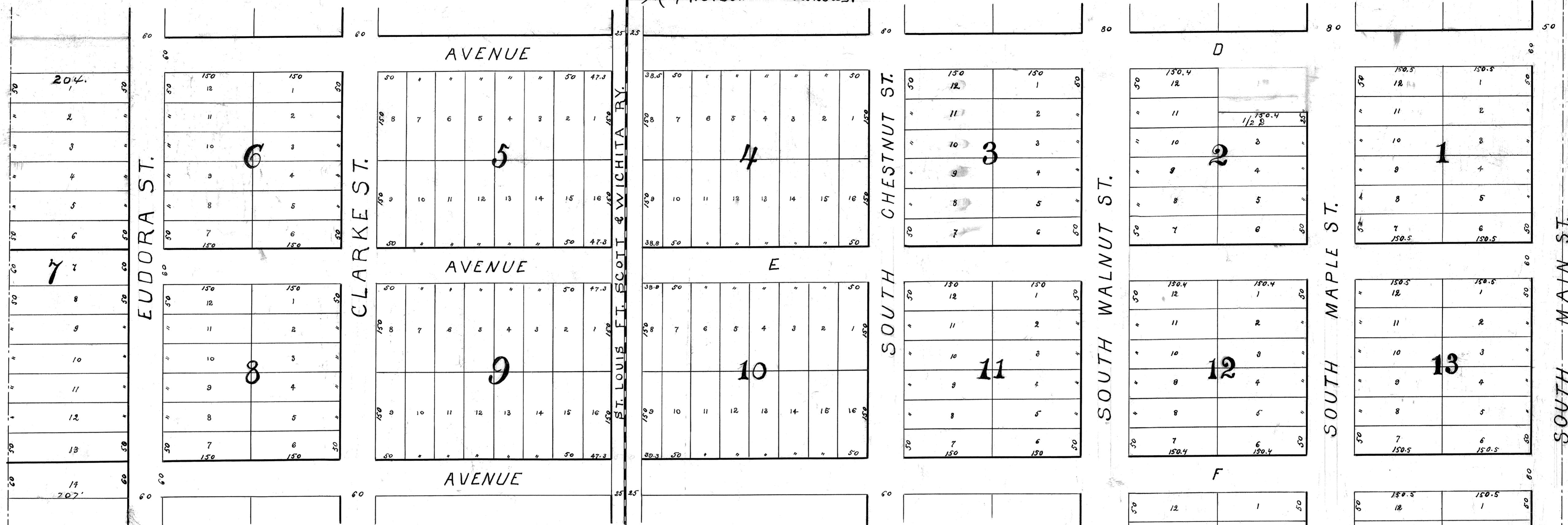


# CLARKE'S 3D. ADDITION

McPherson Kansas.

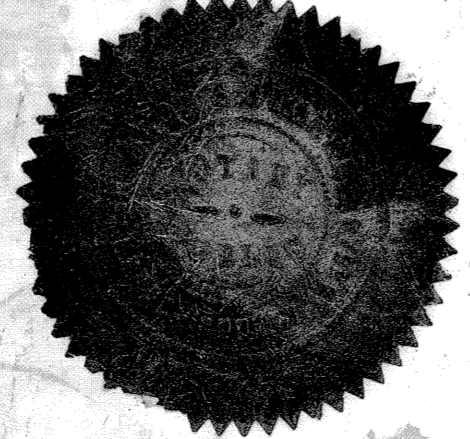


Blocks 5, 6, 7, 8 & 9 "Cancelled by Order"

 The location of Ave E between Blocks 4 & 10, Clarke's third add is in sec. 18 pg 555  
 for location of that portion of Clarke's third add lying West of Missouri Pacific  
 Railroad right of way see Chapter 527 sec. 6 Union Law of 1903.

Clarke's third addition to the city of McPherson Kansas  
 is situated in the North East 1/4 of Sec 32 T. 19 R. 3 West of  
 6th P.M. and is described as follows. Beginning at a point  
 1100 ft south of the 1/4 sec corner between Secs 29 & 32. Thence  
 East 2050.2 ft. Thence south 75 ft. Thence East 150.4 ft.  
 Thence North 75 ft. Thence East 431.1 ft. Thence South  
 1020 ft. Thence West 811.8 ft. Thence North 300 ft. Thence  
 West 1820.6 ft. Thence North 720 ft to place of Beginning.  
 This description is made from T. Cole's survey.  
 Avenue D is identical with Avenue D in Clarke's 1st and 2nd Additions  
 to the City of McPherson Kansas.
