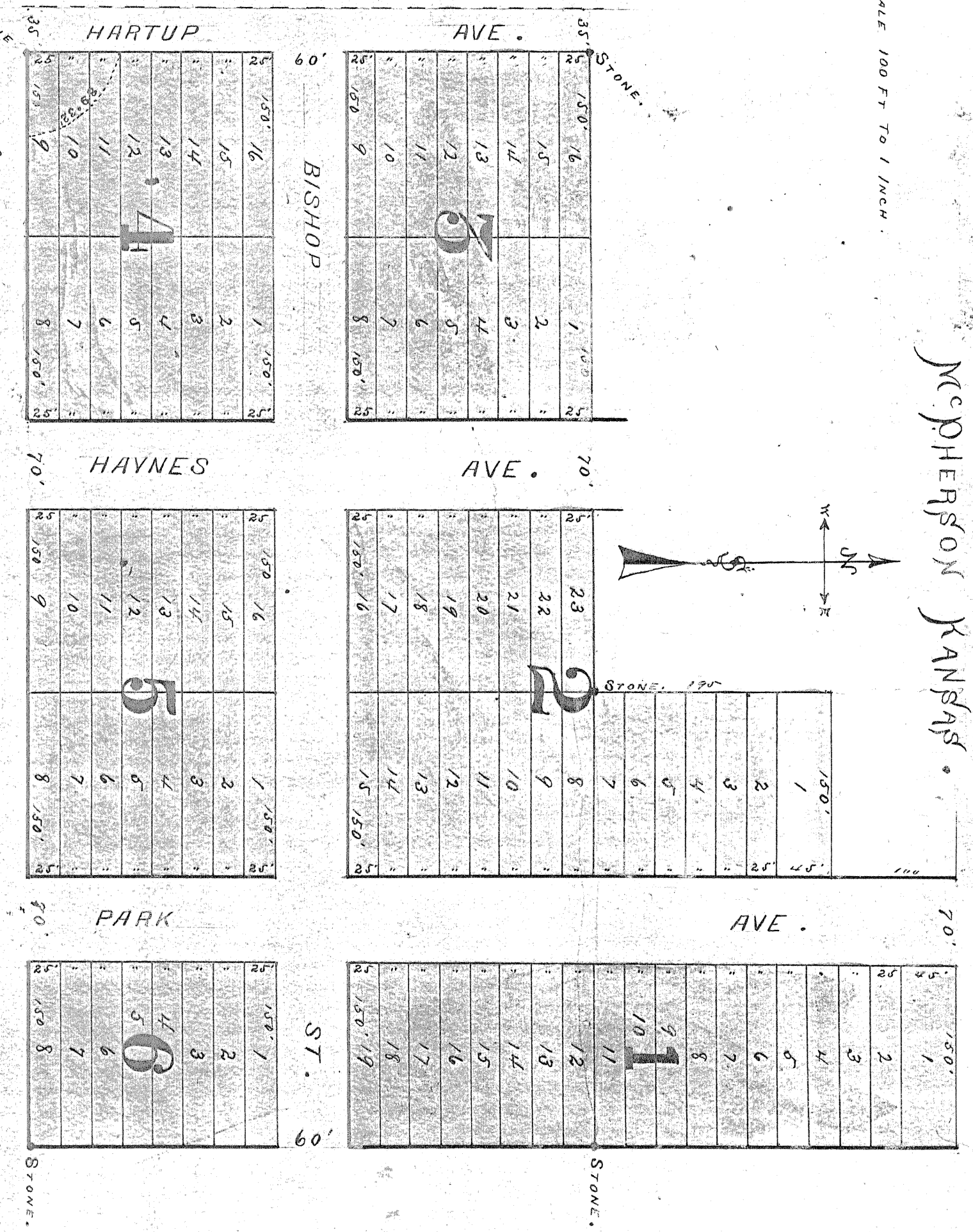


CORRECTED PLAT

By Special Act - Chapter 168, Session Laws 1893 - The Streets, alleys, Lots and Blocks of that part of College Annex to Grand View Addition which is located upon the S.W. 1/4 of the S.E. 1/4 of Sec. 25, Twp. 19 S., of R. 3 N. 6 E. M. and hereby vacated."

College Annex to Grand View Addition to the City of McPherson Kansas is situated in the West 1/2 of the S.E. 1/4 of Sec 25, T19 R32 of the 6<sup>th</sup> P.M. and is more fully described as follows to wit: Beginning at a stone at the S.W. corner of 13<sup>th</sup> St. in Grand View Addition to the City of McPherson Kansas, thence running South along the east side of Hartup Avenue and parallel with the 1<sup>st</sup> section line four hundred and thirty (330) feet to a stone. Thence East eight hundred and thirty (830) feet to a stone. Thence North seven hundred and fifty five (755) feet. Thence North West One hundred and twenty (120) feet, to the S.E. corner of Block five (5) in Grand View Addition to McPherson Kansas, thence South One hundred (100) feet to the South East corner of lot four (4) in the above said Block five in Grand View Addition to the City of McPherson Kansas. Thence West One hundred and fifty feet to the S.W. corner of the above said Block five in above said Grand View Addition. thence North West One hundred and thirty (130) feet to a stone at the S.E. corner of lot five in above said Block five in above said Grand View Addition to the City of McPherson Kansas, thence West along the south side of the West 1/2 of Block five and the south side of Block six in Grand View Addition to the City of McPherson Kansas. Five hundred and twenty (520) feet to place of beginning Hartup Avenue as indicated by the East in that portion in Dinkens Addition to the City of McPherson Kansas, lying East of the 1<sup>st</sup> section line.

This Plat is filed to correct error in the Plat of College Annex to Grand View Addition to the City of McPherson Kansas, as filed on the 30<sup>th</sup> day of August A.D. 1887. I do hereby certify that the above Plat and notes are correct and conform strictly to a survey made by me on the 21<sup>st</sup> day of May A.D. 1888.
