of the 6th P.M. and is described as follows:
Beginning at a point 110 feet East of the 1/4
Section Corner between Secs. 27 and 28 Sp. 19
Range 3 West of 6th P.M. Thence East 1558
feet to the center of said Sec. 27 Thence
North 2627 feet to the 1/4 Sec. corner between
Secs. 22 and 27 Sp 19 Range 3 West of 6th P.M.
Thence West 1158 feet to the Sec. line be-
tween Secs 22 and 27 to the south side of
the Right of way of the M. M. R.R. Thence a
westerly direction 1558 feet along the south
line of the Right of way of the said rail-
road, to the Section line between Secs 27 and 28
Sp 19 Range 3 West, Thence South on the Sec.
line 1058 feet, Thence East 110, Thence South
160 feet to the place of beginning. The above
described land is divided into blocks, lots,
streets and alleys, as shown by the accom-

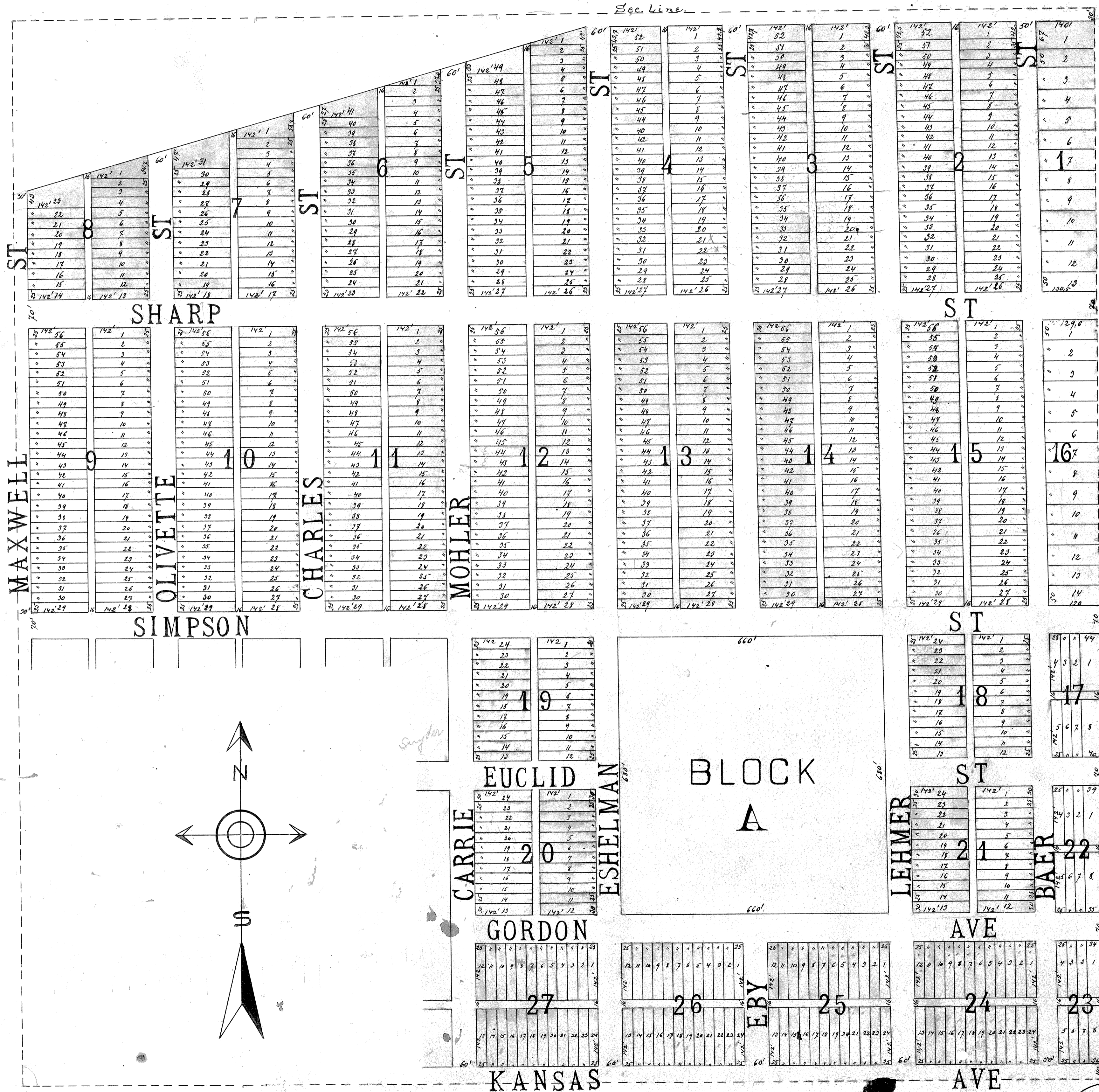
