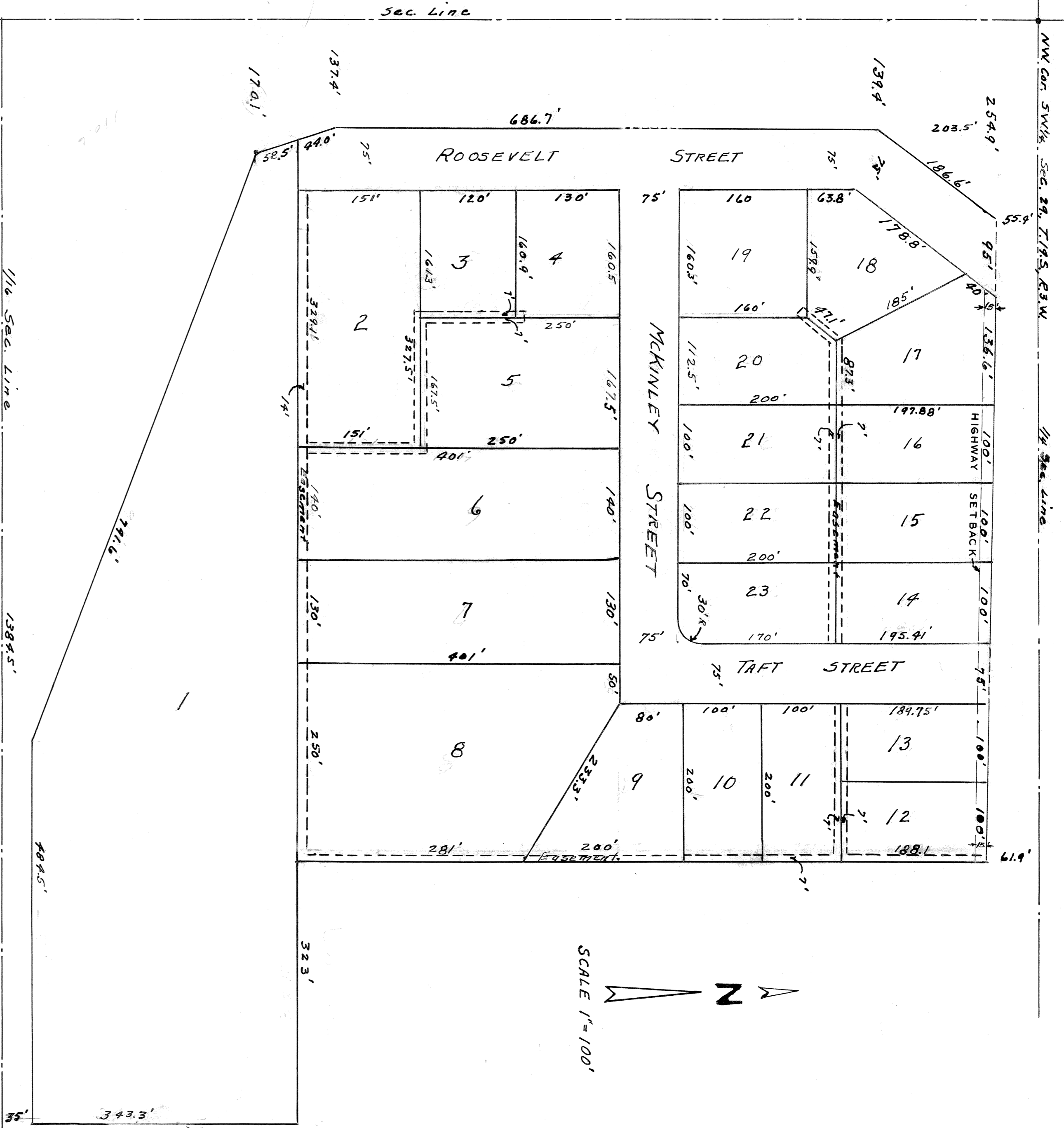


DELMORE TO THE CITY OF McPHERSON KS. ADDITION



KNOW ALL MEN BY THESE PRESENTS, That RW Bremyer and Myrme E. Bremyer, his wife, Gary E. Rurell and Peter Rurell her husband, Mary E. Brandon and Will Brandon, her husband, and Frank H. Bremyer and Myrtle E. Bremyer, his wife, owners and proprietors of the lands hereinafter described, and their respective spouses, have caused said lands to be surveyed and plattd under the name of Delmore Addition to the City of McPherson, Kansas, and have caused the same to be subdivided into blocks and lots, streets, quarters, drives and public ways as shown on the accompanying plat and dedicated to public use. *

Description.
Part of the South west 1/4 of Section Twenty nine (29), Township Nineteen (19) South, Range Three (3) West of the 6th, P.M., more particularly described as follows, to-wit: Beginning at a point two hundred fifty four and nine tenths (254.9) feet east and fifty five and four tenths (55.4) feet south of the northwest corner of the Southwest Quarter of Section Twenty nine (29), Township Nineteen (19) South, Range Three (3) West of the 6th, P.M., thence east Eight Hundred Six and Six tenths (806.6) feet to a point, thence east Eight Hundred Six and Six tenths (806.6) feet to a point, thence south West Quarter (SW 1/4) of said Section Twenty nine (29), thence south Eight Hundred Sixty Nine and one tenth (869.1) feet parallel to the west line of said section twenty nine (29), thence east three hundred twenty three (323) feet, thence south three hundred thirty three (333) feet to the south line of the north one half (N 1/2) of said South west Quarter (SW 1/4) of said Section Twenty nine (29) and One thousand three hundred Eighty Four and five tenths (1384.5) feet east of west line of said Section Twenty nine (29), thence west four hundred Eighty Four and five tenths (484.5) feet parallel to the south line of North One Half (N 1/2) of said North West Quarter (SW 1/4) of said Section Twenty nine (29), thence North Westerly Seven Hundred Ninety One and six tenths (791.6) feet to a point, One hundred Seventy Nine (29), thence North westerly One Hundred Two and five tenths (102.5) feet to a point, One hundred Thirty Seven and four tenths (137.4) feet east of west line of said Section Twenty nine (29), thence north Six Hundred Eighty Six and seven tenths (686.7) feet to a point, One Hundred Thirty Nine and four tenths (139.4) feet east of west line of Section Twenty nine (29) and Four tenths (39.4) feet east of west line of Section Twenty nine (29) north line of said South west Quarter (SW 1/4) of said Section Twenty Nine (29), thence northwesterly One Hundred Eighty Six and six tenths (186.6) feet to the place of beginning.
