

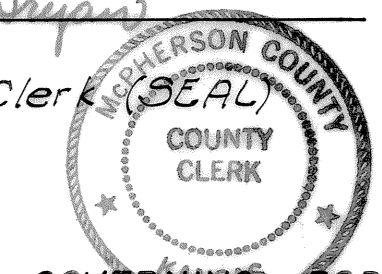

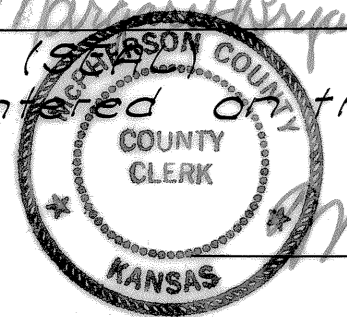

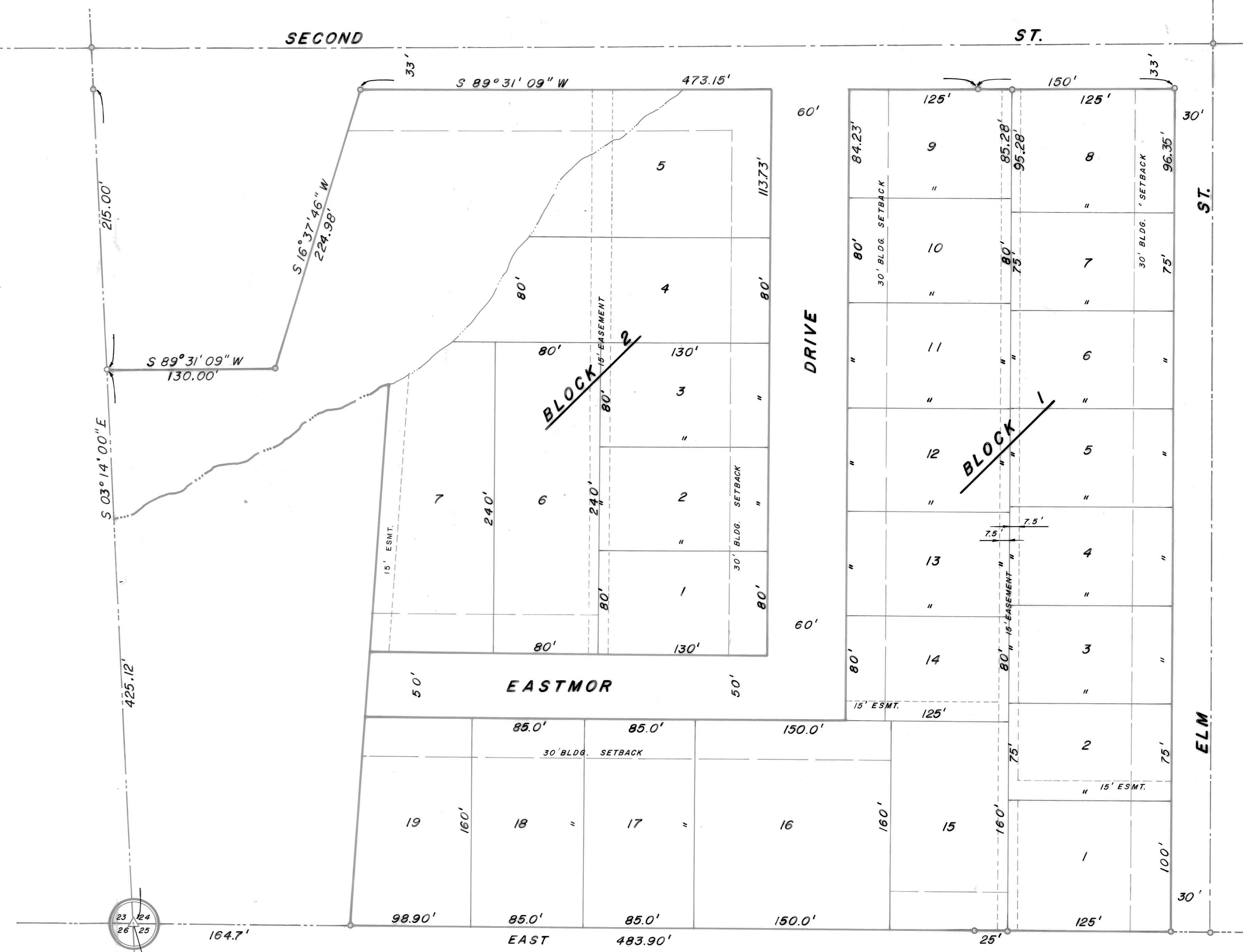

DESCRIPTION

Beginning at a point on the E-W Section line 164.7 feet East of the S.W. Cor. Sec. 24, T17S, R5W; thence East on said Section Line to the West Right of Way line of Elm St.; thence North along the West line of Elm Street to the South side of Second St; thence West along the South side of Second St. to a point 10 feet East of the Northeast corner of Block 5, in Fairview Addition; thence in a South-westerly direction, parallel to the East line of Blk. 5, to a point that intersects a line 30 feet South and parallel to the South line of Block 5; thence West parallel to and thirty feet South of the South side of Block 5 to the N-S Section line; thence South on the Section line to the centerline of a ravine, sometimes known as Dry Creek; thence in a Northeasterly direction along the centerline of Dry Creek, to a point that is 202.7 feet East of the N-S Section line and 420 feet North-North-Easterly from the point of beginning; thence 420 feet South-South-Westerly to the point of beginning.

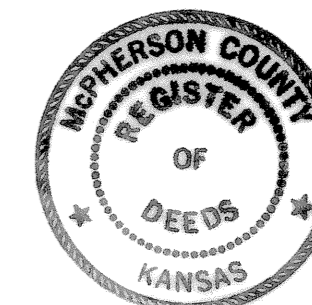
