

Free Mount Kansas.

Know all men by these Presents, That Char. J. Strongquist, being the owner and proprietor of a tract of land, located in the North East Quarter of Section Twenty nine (29) Township Seventeen (17) South, Range Four (4) west of the 6th P.M. in McPherson County State of Kansas, has caused the said tract to be surveyed, laid out and platted as and for the original town of "Free Mount" Kansas. The said tract located as above mentioned, is more fully described within the following meets and bounds to wit:

Commencing at the South East corner of the said Quarter section, thence running west along the south line of said Quarter section, Thirteen Hundred and Twenty feet (1320) feet thence north and parallel with the east line of said Quarter section Thirteen Hundred and Thirty three (1333) feet, to the north line of the S.E. 1/4 of said Quarter section, thence East along the north line of the S.E. 1/4 of said Quarter section Thirteen hundred and twenty (1320) feet, to the East line of said Quarter section Thirteen hundred and thirty (1330) feet, to the place of beginning, Containing Forty and thirty five one hundredths (40.35) Acres, less the Right of way of the Council Grove, Smoky Valley and Western Rail Road, I further publish and declare, that the said Town of "Free Mount" is laid out into Blocks, Lots, Streets and Alleys, as shown on the Map herewith attached. The Blocks are named by figures in the natural sequence of numbers, and are subdivided into Lots which are further designated in a similar manner. All ground in said Town of "Free Mount" that are intended for public purposes such as streets and alleys, are as shown on the Map herewith attached, and their names courses and widths marked thereon. The dimensions of Lots are as marked on the map herewith attached, in figures representing feet and tenths of feet, Lots bounding on Third and Fourth streets not so marked are subject to Admeasurement. I further declare that the Map herewith attached is a true and correct representation of said Town of "Free Mount" and fully concurs with all statements and facts set fourth in this certificate and referred thereto.
