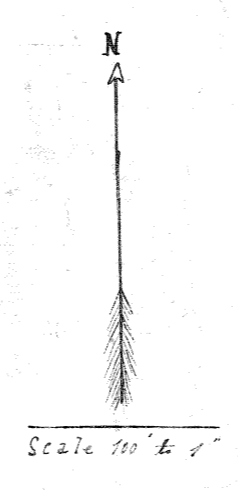

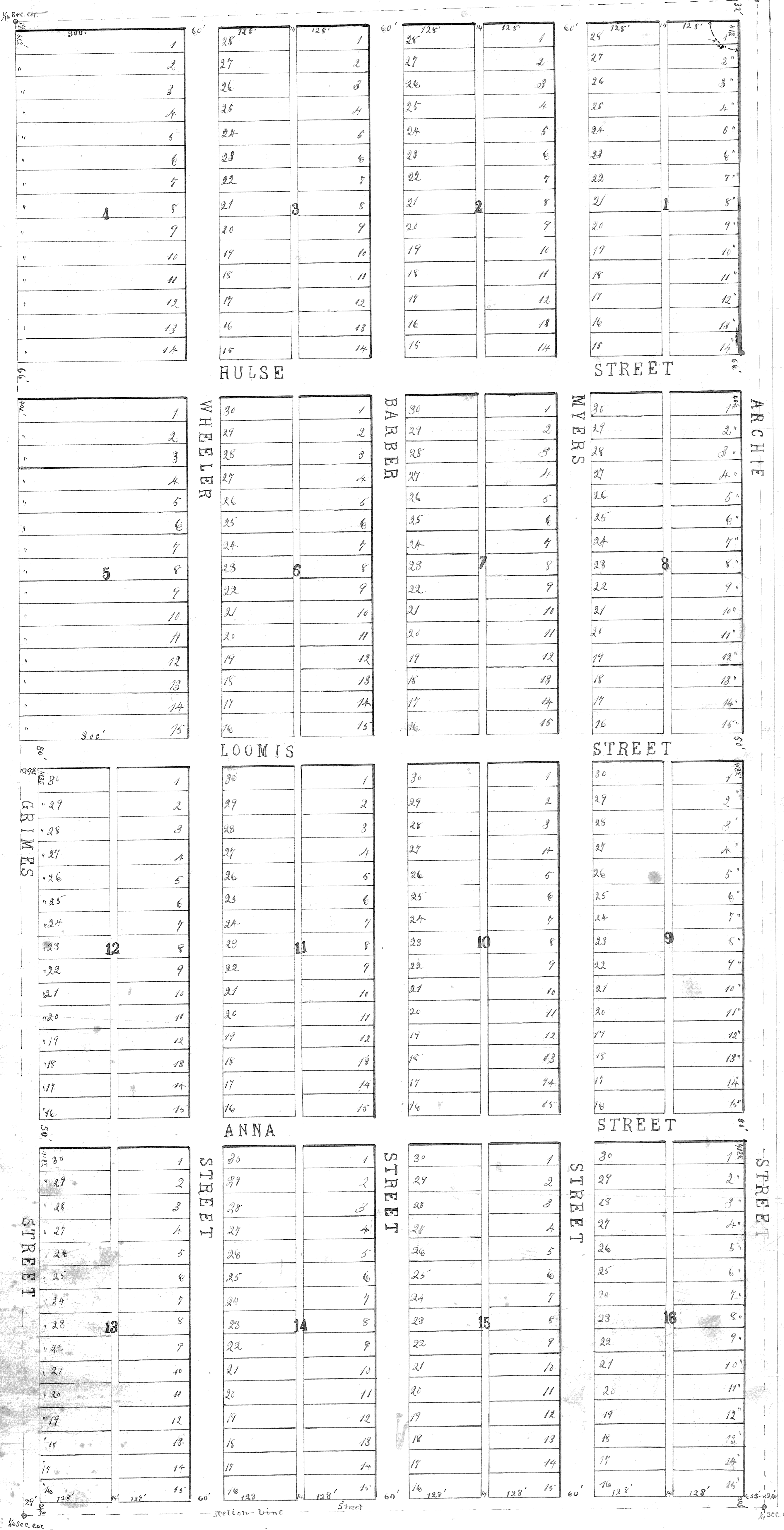

Freeman Addition to the City of M^r Pherson

Surveyor's Statement and Certificate

Freeman Addition to the City of M^r Pherson, as shown and platted hereon, is bounded and described as follows, to-wit: The East half (1/2) of the South-West quarter (1/4) of Section number twenty one (21) in Township number nineteen (19) South of Range number three (3) West of the 6th principal meridian, and a strip twenty feet in width off of the West side of the West half (1/2) of the South-East quarter (1/4) of Section number twenty one (21) in Township number nineteen (19) South of Range number three (3) West of the 6th principal meridian.

The street on the East (being main street) is Fifty Five feet wide. The half (1/2) street on the West (being Union street) and extending from the south line of said addition North to Union street) is Twenty Nine feet wide at South end, and Twenty Nine and Eight Tenths (29 8/10) feet wide at North end. The half street on the South is Twenty Four and Eight Tenths (24 8/10) feet wide at West end and Twenty and Three Tenths (20 3/10) feet wide at East end. Union street is Sixty Six (66) feet wide. All other streets running East and West are Fifty (50) feet wide. All other streets running North and South are Sixty (60) feet wide. All alleys are Fourteen (14) feet wide. All lots are One Hundred and Twenty Eight (128) feet long, except lots in Block Four (4) and Five (5) which are Three Hundred (300) feet long. All lots in Block One (1) Two (2) Three (3) and Four (4) are Sixty One and Eight Tenths (61 8/10) feet wide. All lots in Block Two (2) Six (6) and Seven (7) are Fifty and One Tenth (50 1/10) feet wide. All other lots are Fifty One and Thirty Two Hundredths (51 32/100) feet wide. All lots and blocks as shown on plat. The strip of land along the South is not included in this addition.

I, A. Bass, of M^r Pherson County, Kansas, do hereby certify that the foregoing plat and statement and certificate being a part of the plat and said plat being the same plat on which this certificate is indorsed, are true and correct in every particular, and is an accurate plat of the premises described and is platted as an addition to the City of M^r Pherson, Kansas known and designated as Freeman Addition to the City of M^r Pherson, and conforms strictly to the actual survey made by me on the 21st day of May 1886.
