



FROESE SECOND ADDITION INMAN, KANSAS.



KNOW ALL MEN BY THESE PRESENTS, That H. Eddie Froese and Verna Froese, his wife owners and proprietors of land hereinafter described, have caused said land to be surveyed and plotted under the name of Froese Second Addition to the City of Inman, Kansas and caused the same to be subdivided into Block, Lots, Alley and Streets as shown on accompanying Plat.

DESCRIPTION. Part of East Half of North West Quarter (E 1/2, NW 1/4) of Section Sixteen (16). Township Twenty One (21) South, Range Four (4) West, 6th P.M. Beginning 1323.5 feet East and 1284 feet South of Northwest Corner of said Section 16 at Southwest Corner of Froese Addition to the City of Inman, Kansas and 16 feet North of Northeast Corner of Wien's Addition to the City of Inman, Kansas. Thence South 851 feet to point 19 feet South of Southeast Corner of Sunnydale Addition to the City of Inman, Kansas. Thence east 196.5 feet parallel with North line of Oliver Street extended east, Thence north 851 feet to Southeast Corner of said Froese Addition, Thence West 196.5 feet to the place of beginning.

All Streets and Alleys are hereby dedicated to and for use of the Public.
