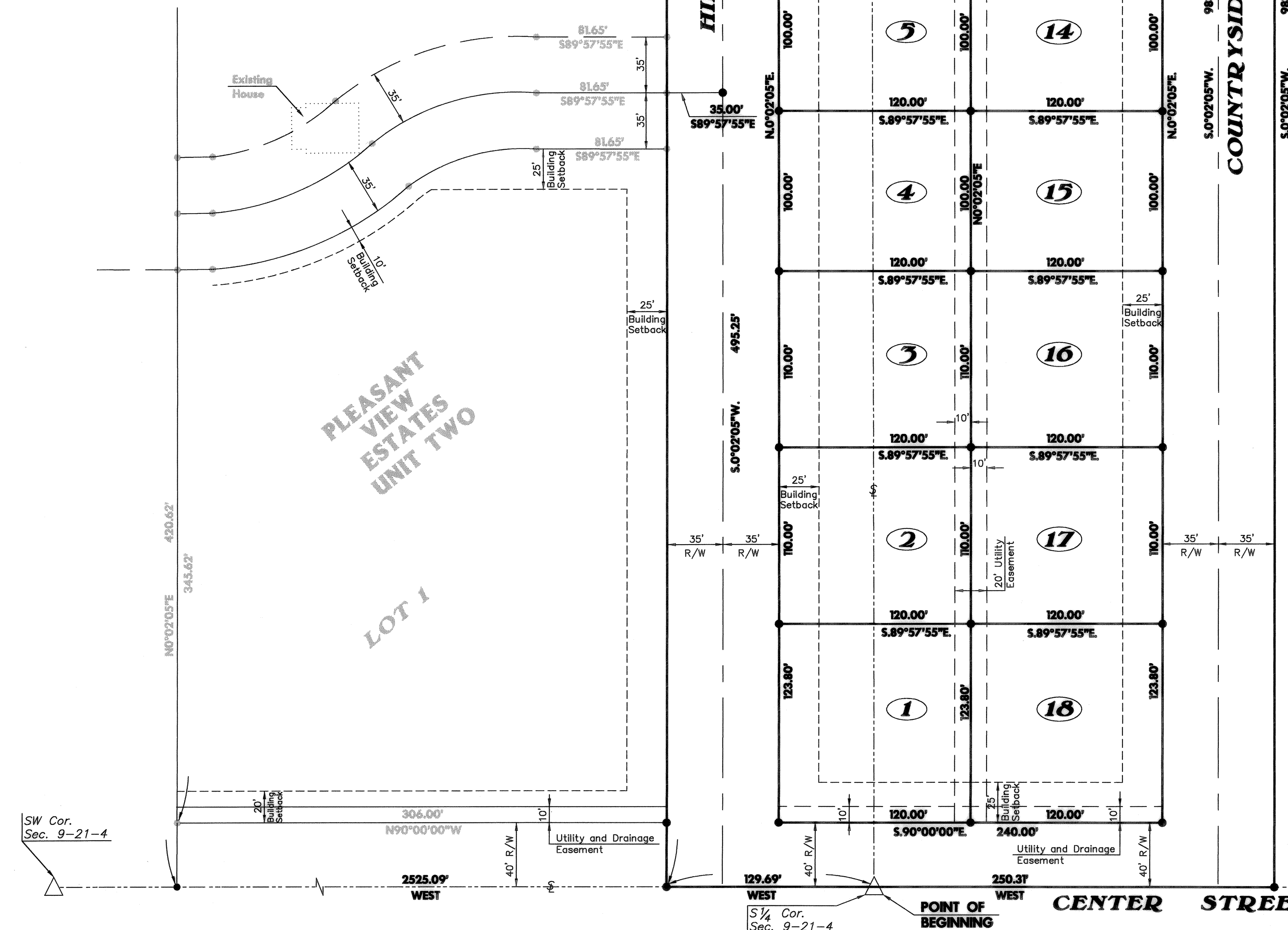


DESCRIPTION

A TRACT OF LAND LOCATED IN THE EAST HALF OF THE SOUTHWEST QUARTER AND THE WEST HALF OF THE SOUTHEAST QUARTER OF SECTION 9, TOWNSHIP 21 SOUTH, RANGE 4 WEST OF THE 6TH P.M. IN MCPHERSON COUNTY, KANSAS, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTH QUARTER CORNER OF SAID SECTION 9; THENCE ALONG THE SOUTH LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 9 WEST 129.69 FEET TO THE SOUTHEAST CORNER OF THE PROPOSED "PLEASANT VIEW ESTATES, UNIT TWO", AN ADDITION PROPOSED TO THE CITY OF INMAN; THENCE ALONG THE EAST LINE OR EXTENDED EAST LINE OF SAID PROPOSED "PLEASANT VIEW ESTATES, UNIT TWO" N.0°02'05"E. 983.91 FEET; THENCE S.89°57'55"E. 380.00 FEET; THENCE S.0°02'05"W. 983.68 FEET TO A POINT ON THE SOUTH LINE OF THE SOUTHEAST QUARTER OF SAID SECTION 9; SAID POINT BEING 2404.24 FEET WEST OF THE SOUTHEAST CORNER OF SAID SECTION 9; THENCE ALONG THE SOUTH LINE OF THE SOUTHEAST QUARTER OF SAID SECTION 9 WEST 250.31 FEET TO THE POINT OF BEGINNING, CONTAINING 8.582 ACRES.

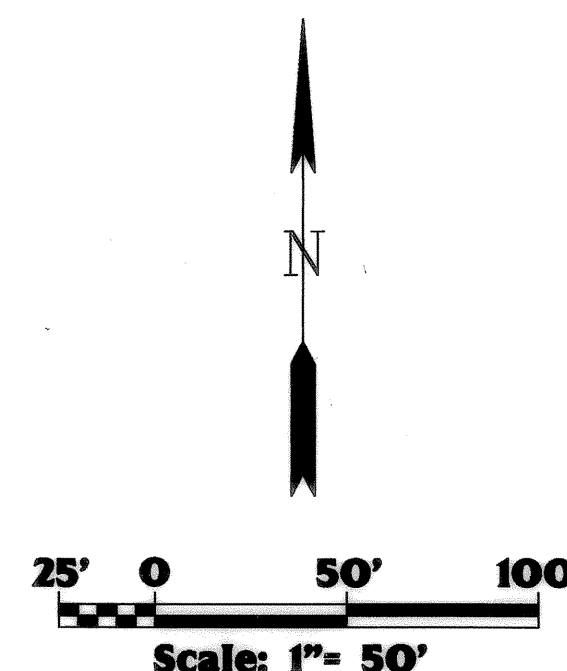

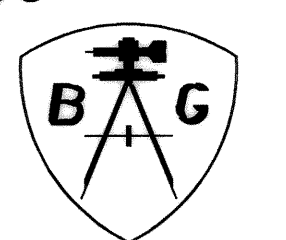
