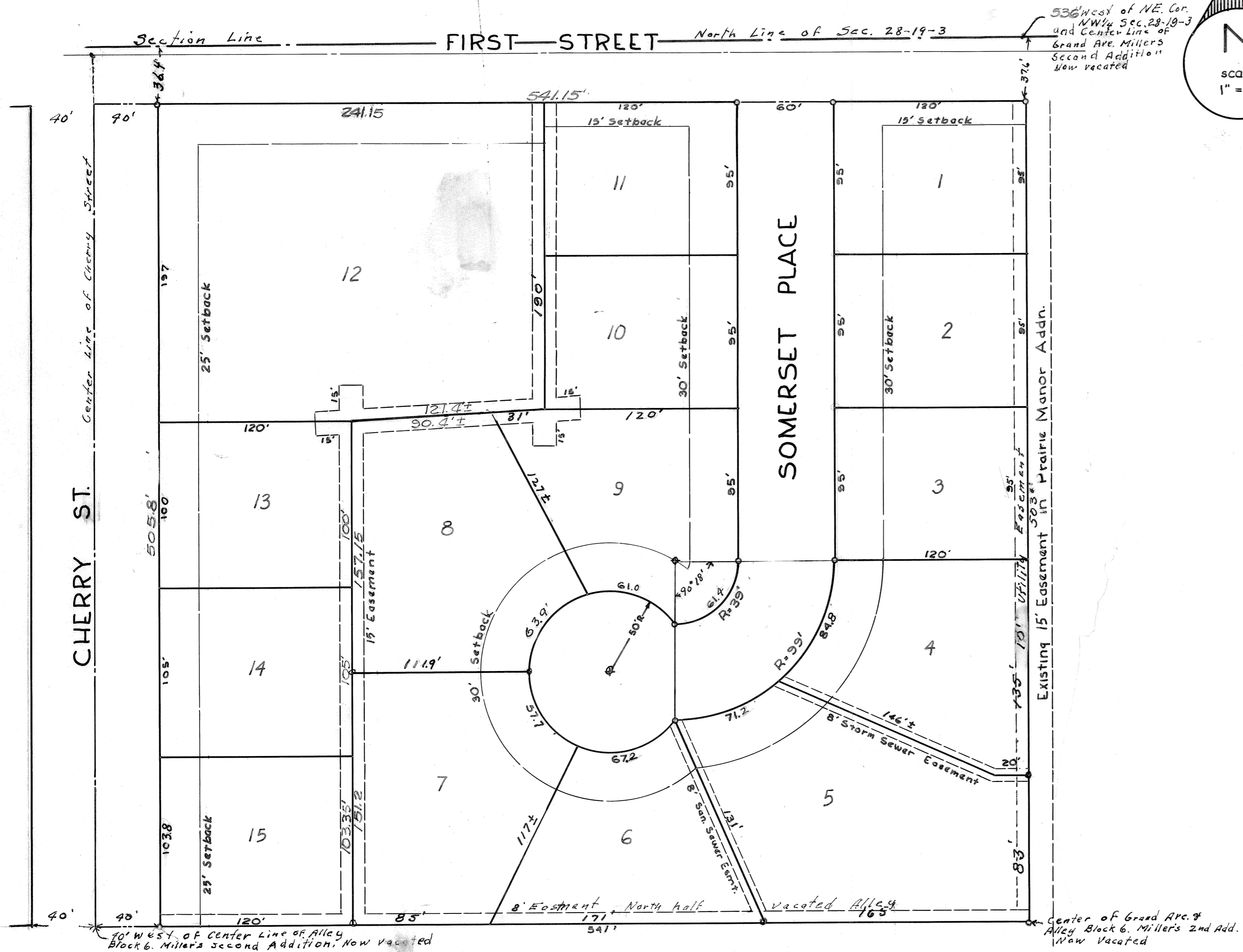
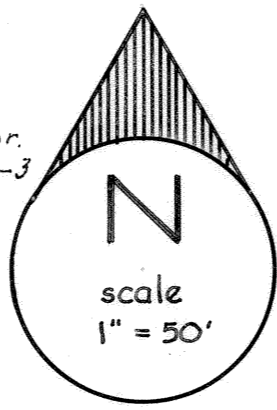


# GLENWOOD HEIGHTS ADDITION

 Description: Originally Block 3 and North Half Block 6, Miller's Second Addition, including all vacated streets and alleys, City of McPherson, also described as follows: Beginning at the Northeast corner of North West Quarter (NW<sup>1/4</sup>), Section 28, Township 19, South, Range 3, West, 6<sup>th</sup> P.M. thence west 536 feet more or less to center of Grand Avenue as shown by plat of Miller's Addition No. 2 to McPherson (now vacated) for a place of beginning, thence West 581.15 feet more or less to the center of Cherry Street in said addition, thence south 505.8 feet more or less to a point 90 feet west of the center of the alley in Block 6 of said Addition, thence East 581 feet to center of Grand Avenue in said Addition, thence North 503 feet more or less to place of Beginning
