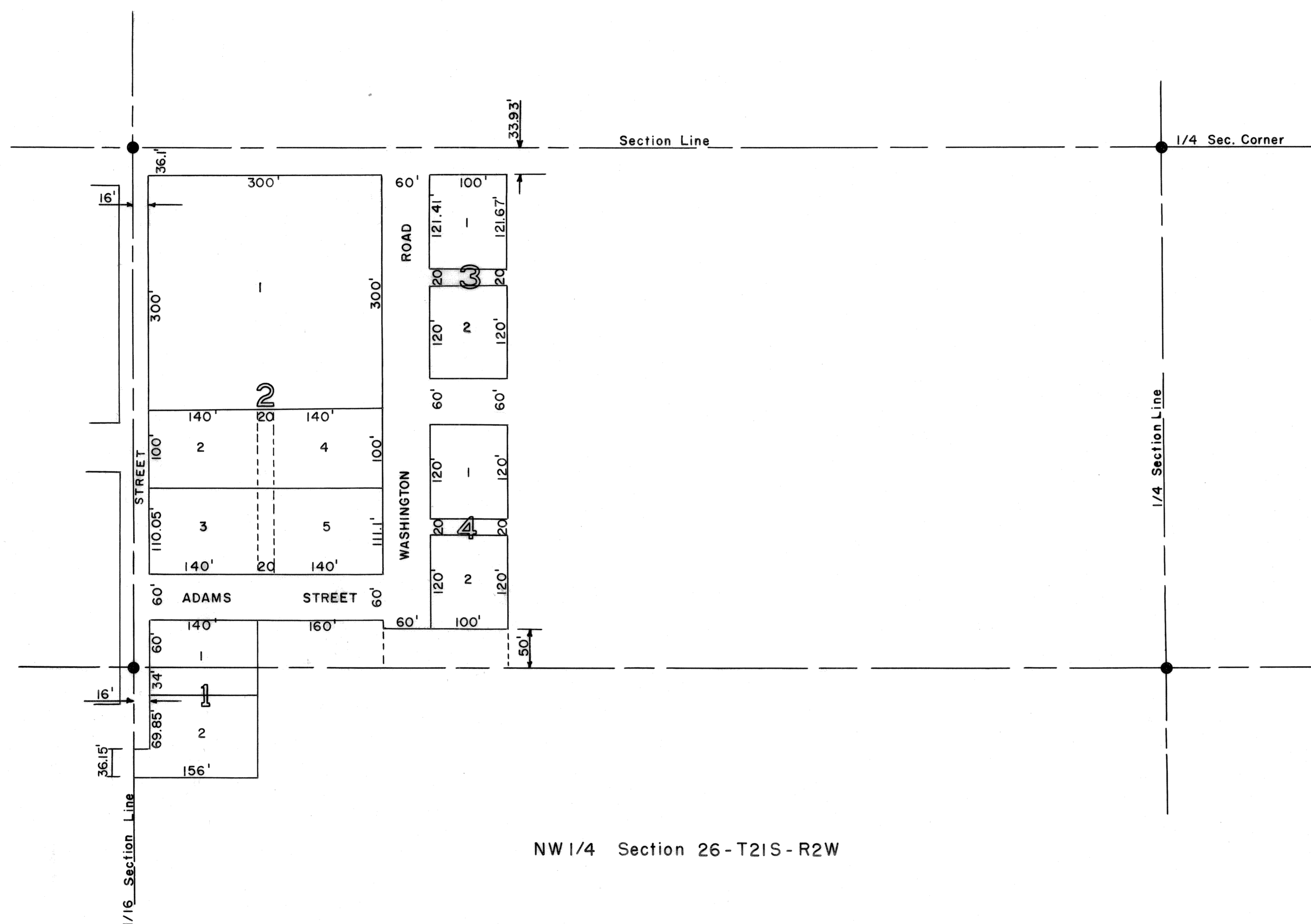


GOERING ADDITION TO THE CITY OF MOUNDRIDGE KANSAS
