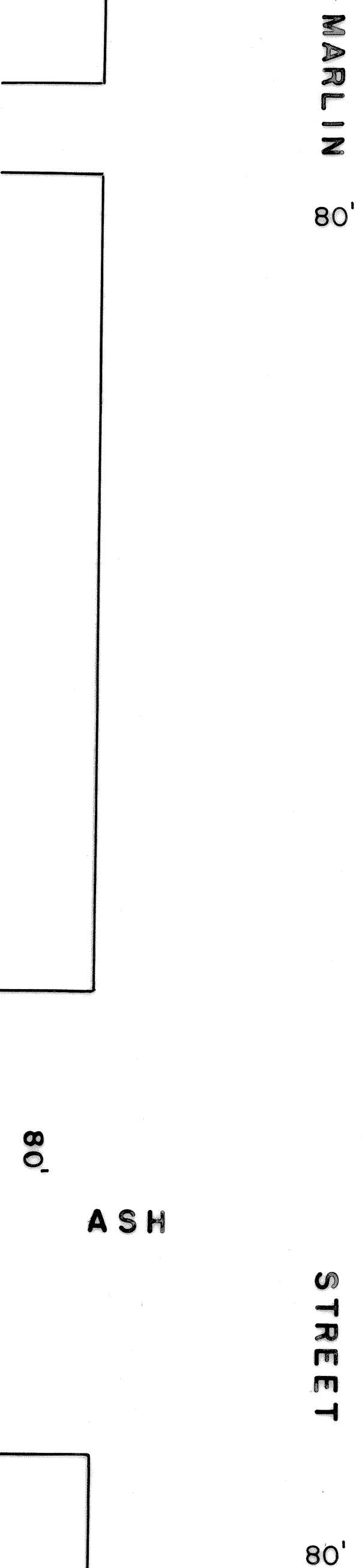
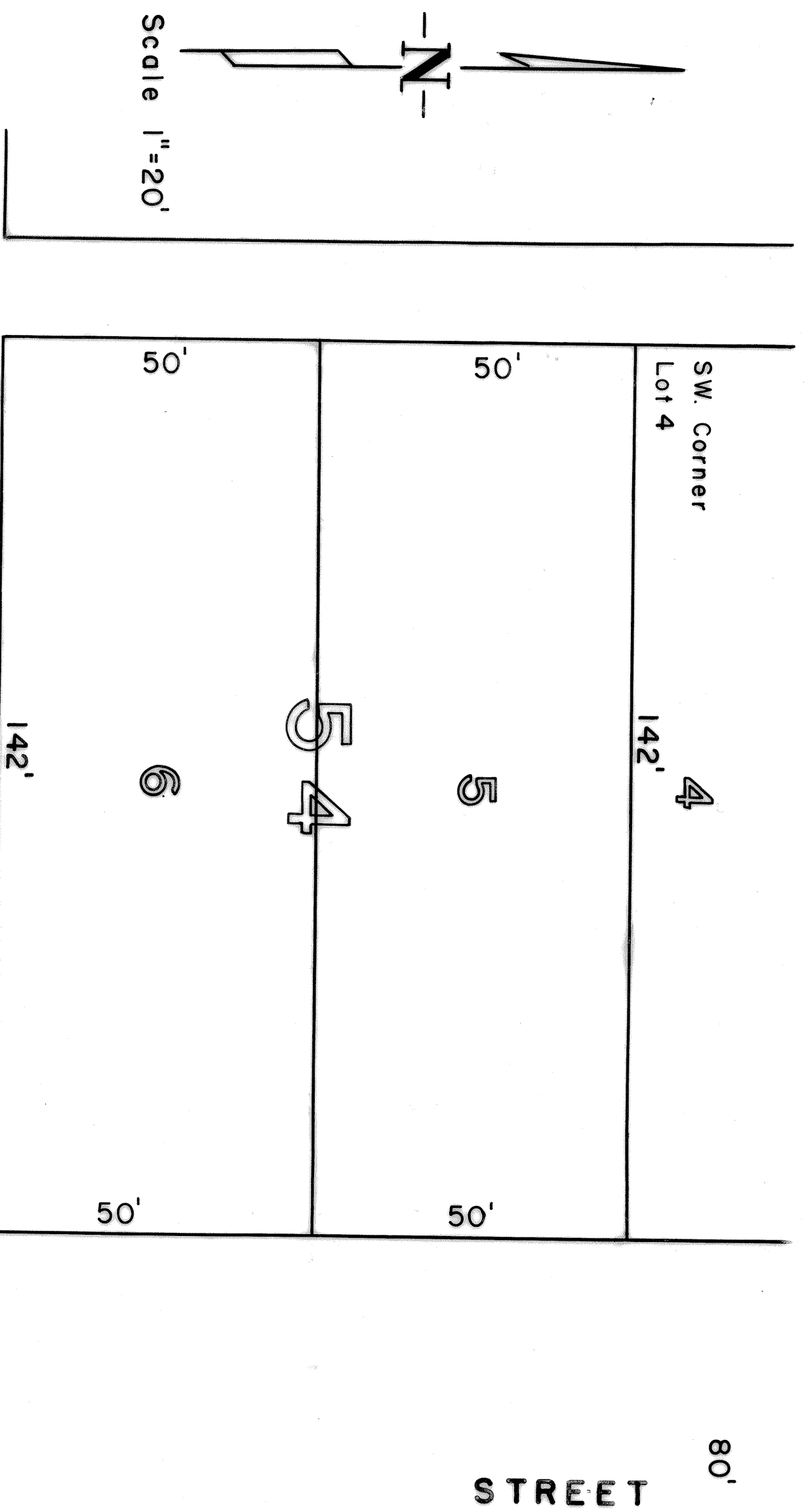

Riddell and Norma Lee Riddell, his wife, owners and proprietors of the lands hereinafter described, have caused the said lands to be surveyed and replatted as a part of the original town of McPherson, Kansas, and have caused the same to be redivided into lots, as shown on the accompanying plat to the public use.

Block of Grimes and Edwards Subdivision, and Lots Five (5) and Six (6), Block Fifty-Four, McPherson, McPherson County, Kansas.

A tract of land in the city of McPherson, Kansas, one hundred and forty-two (142) by one hundred (100) feet square, more particularly described as follows: Beginning at the Southwest Corner of Lot Four (4), Block Fifty-Four (54), McPherson, thence South One Hundred (100) feet to the North line of Marlin Street, thence One Hundred Forty two (142) feet east along said North line, thence North to the South line of said Lot (4), thence West along said North line to place of beginning, formerly platted as part of Grimes & Edwards Subdivision of McPherson.

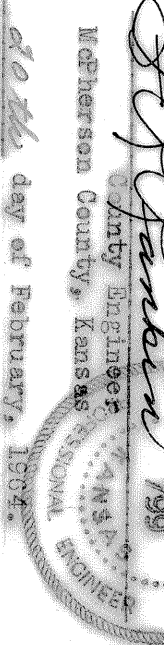
