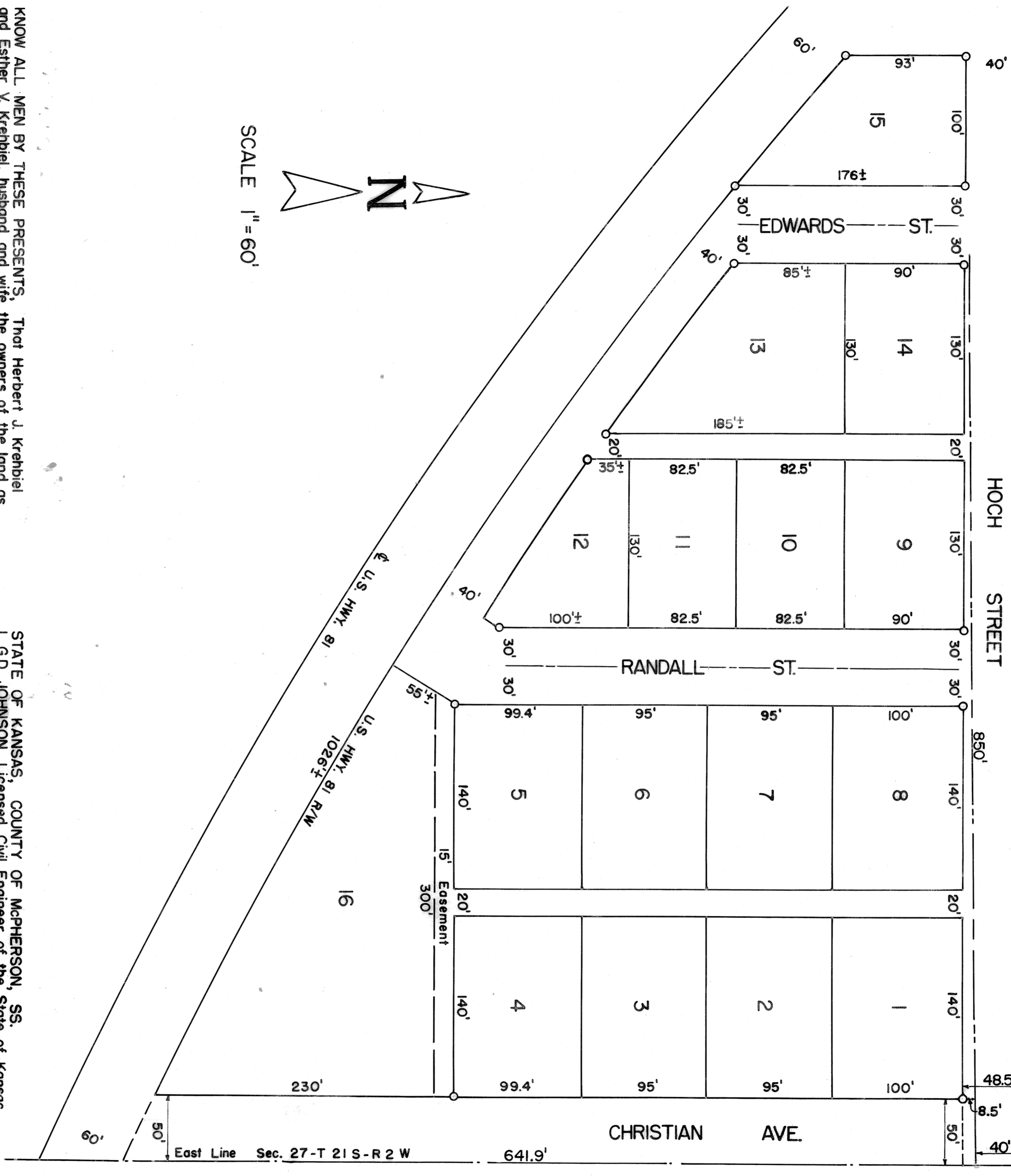


# HERB J. KREHBIEL'S ADDITION MOUNDRIDGE, KANSAS
