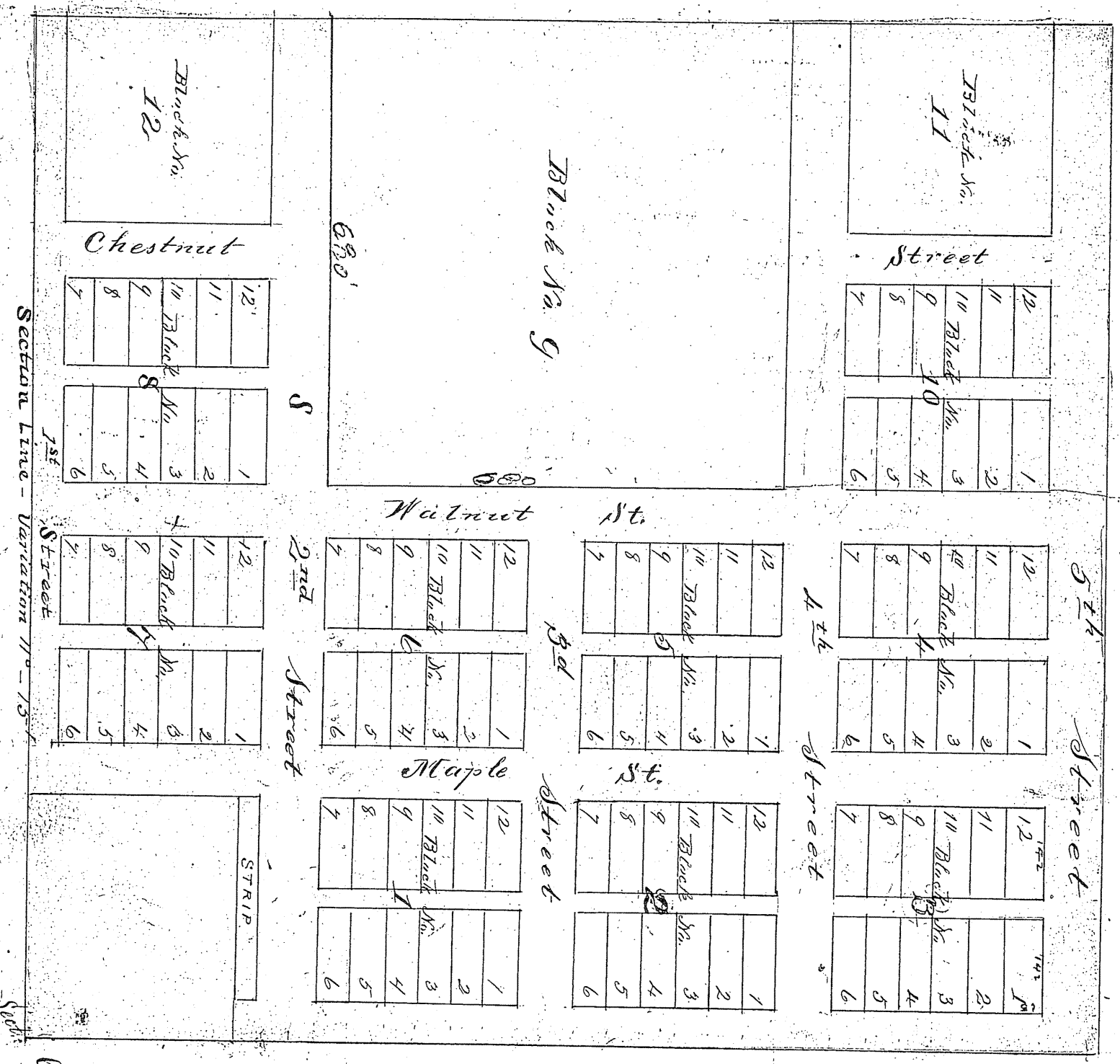


HIGHLAND TO ADDITION

Highland Addition to McPherson - Commencing five claims North of the South East quarter of section No. 20 in Township No. 19 South in Range No. 3. West of the 6th Principal Meridian Thence West 350 feet Thence South 350 feet, Thence west on South line of Section Variation 11° 15' 1140 feet Thence North variation 10° 45' 1565 feet Thence East to East line of section 1490, Thence South on East line of Section to place of beginning 1262 feet. The said Plat of ground is subdivided into Blocks Lots. Streets & Alleys Blocks 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 are each 300 feet square and subdivided into 12 lots 50 feet by 122 feet wide Alley through the Block 16 feet wide running North & South, Blocks 7 & 8 are 300 feet by 315 feet each & subdivided into 12 lots each 50 feet by 142 except lots 1 & 12 in each block 65 feet by 142 feet, Block No. 11 is 300 feet by 315. Block No. 9 is 680 feet square & Black No. 12 is 45 300 feet square. The last three blocks mentioned are not subdivided. The small strip of land, platted strip south of Block 1 and 2nd street is 28 feet by 300 feet There are Main street 50 feet wide Maple Street, Walnut & Chestnut streets each 80 feet wide running North & South. First Street 30 feet wide 2nd 3rd 4th & 5th Street each 80 feet wide & running East & West. Scale of Plat 100 feet to half inch
