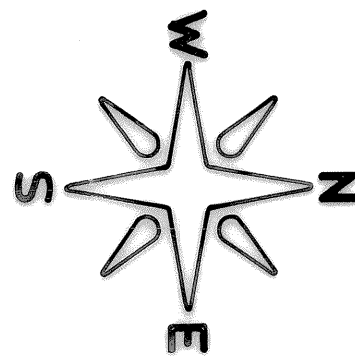

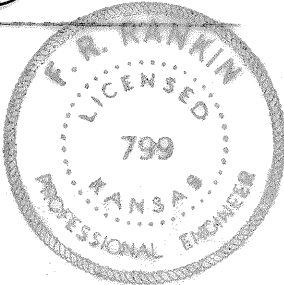

SURVEYORS CERTIFICATE AND DESCRIPTION

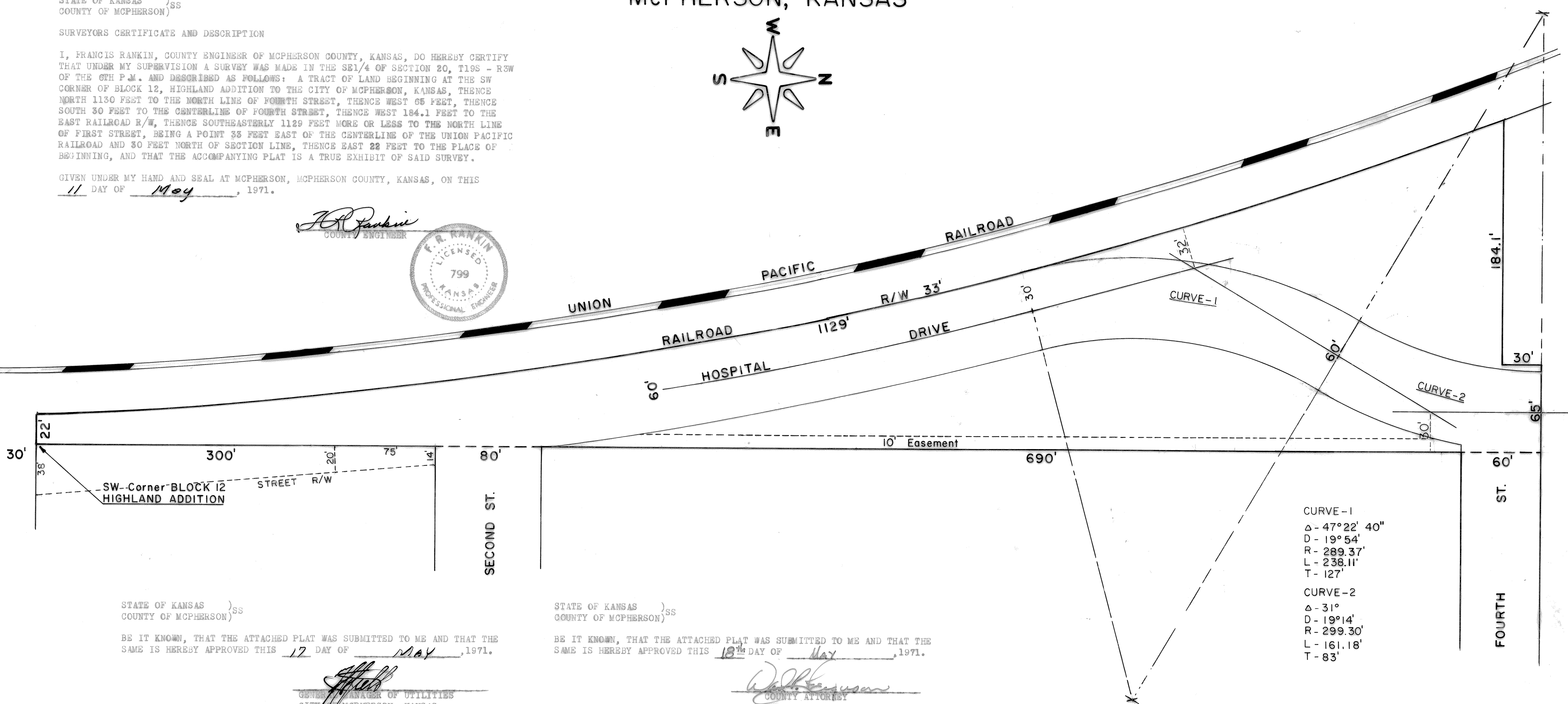
I, FRANCIS RANKIN, COUNTY ENGINEER OF MCPHERSON COUNTY, KANSAS, DO HEREBY CERTIFY THAT UNDER MY SUPERVISION A SURVEY WAS MADE IN THE SE1/4 OF SECTION 20, T19S - R3W OF THE 6TH P.M. AND DESCRIBED AS FOLLOWS: A TRACT OF LAND BEGINNING AT THE SW CORNER OF BLOCK 12, HIGHLAND ADDITION TO THE CITY OF MCPHERSON, KANSAS, THENCE NORTH 1130 FEET TO THE NORTH LINE OF FOURTH STREET, THENCE WEST 85 FEET, THENCE SOUTH 30 FEET TO THE CENTERLINE OF FOURTH STREET, THENCE WEST 184.1 FEET TO THE EAST RAILROAD R/W, THENCE SOUTHEASTERLY 1129 FEET MORE OR LESS TO THE NORTH LINE OF FIRST STREET, BEING A POINT 33 FEET EAST OF THE CENTERLINE OF THE UNION PACIFIC RAILROAD AND 30 FEET NORTH OF SECTION LINE, THENCE EAST 22 FEET TO THE PLACE OF BEGINNING, AND THAT THE ACCOMPANYING PLAT IS A TRUE EXHIBIT OF SAID SURVEY.

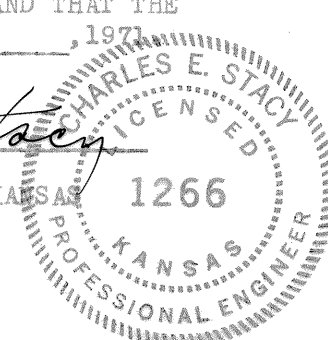

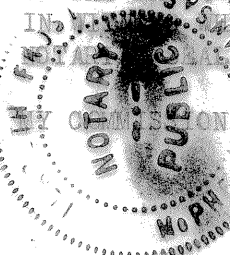

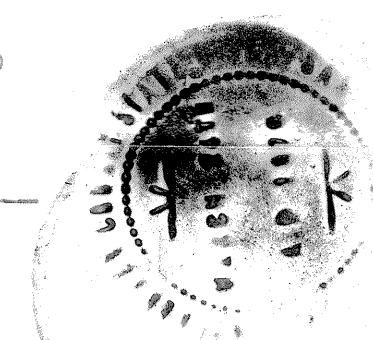
