

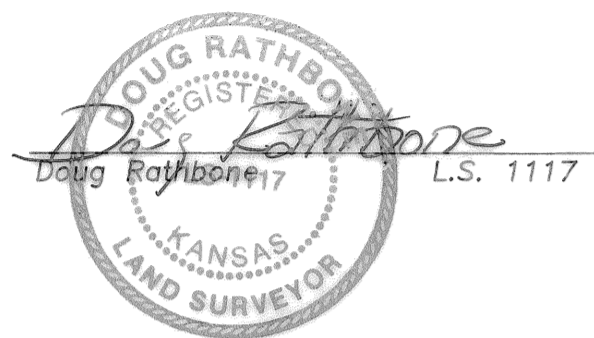
SURVEY CERTIFICATE AND DESCRIPTION

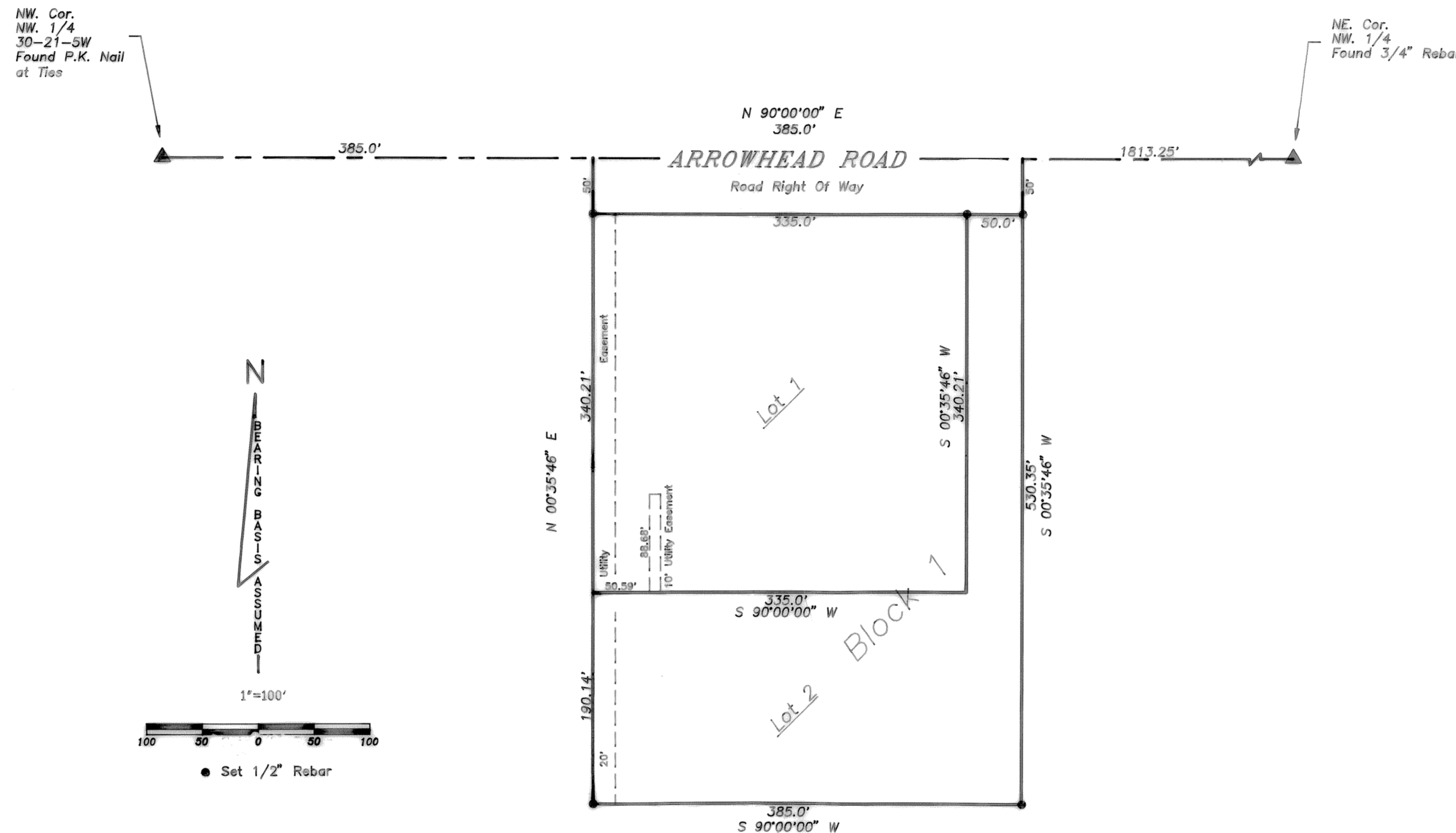

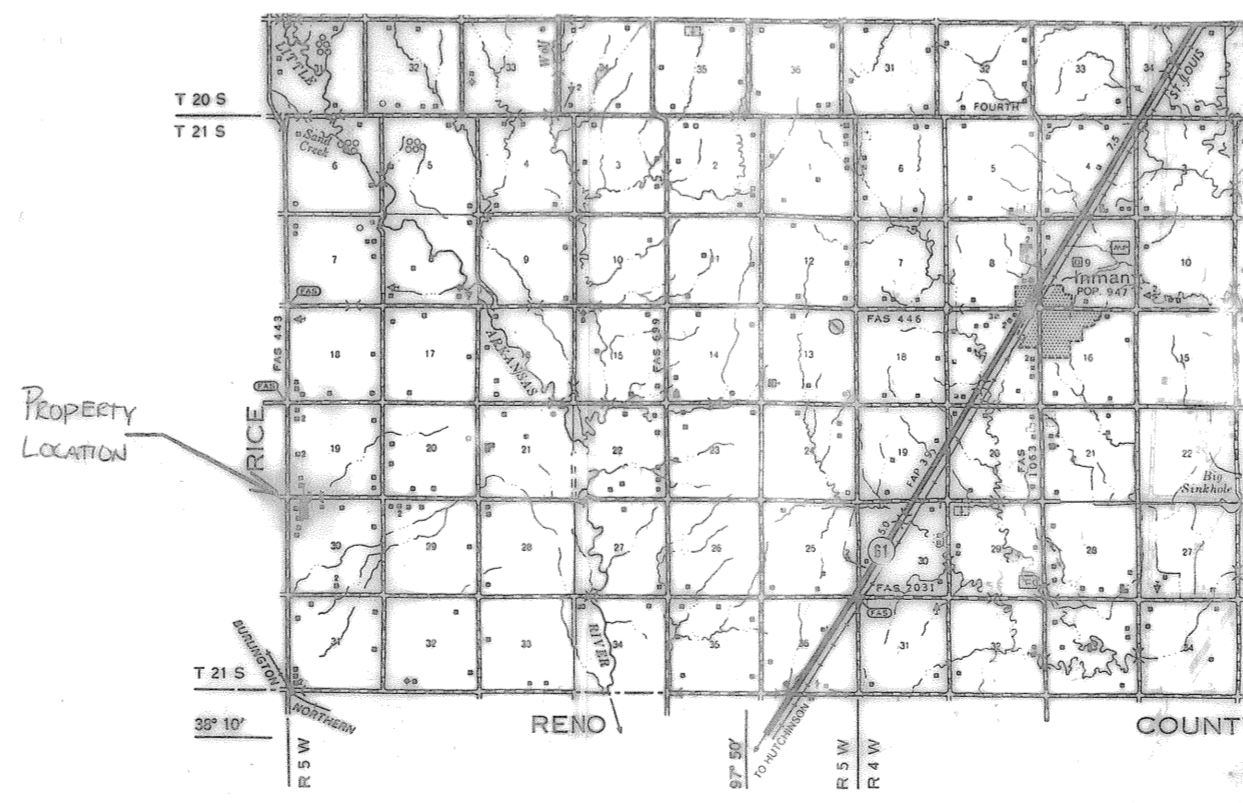
