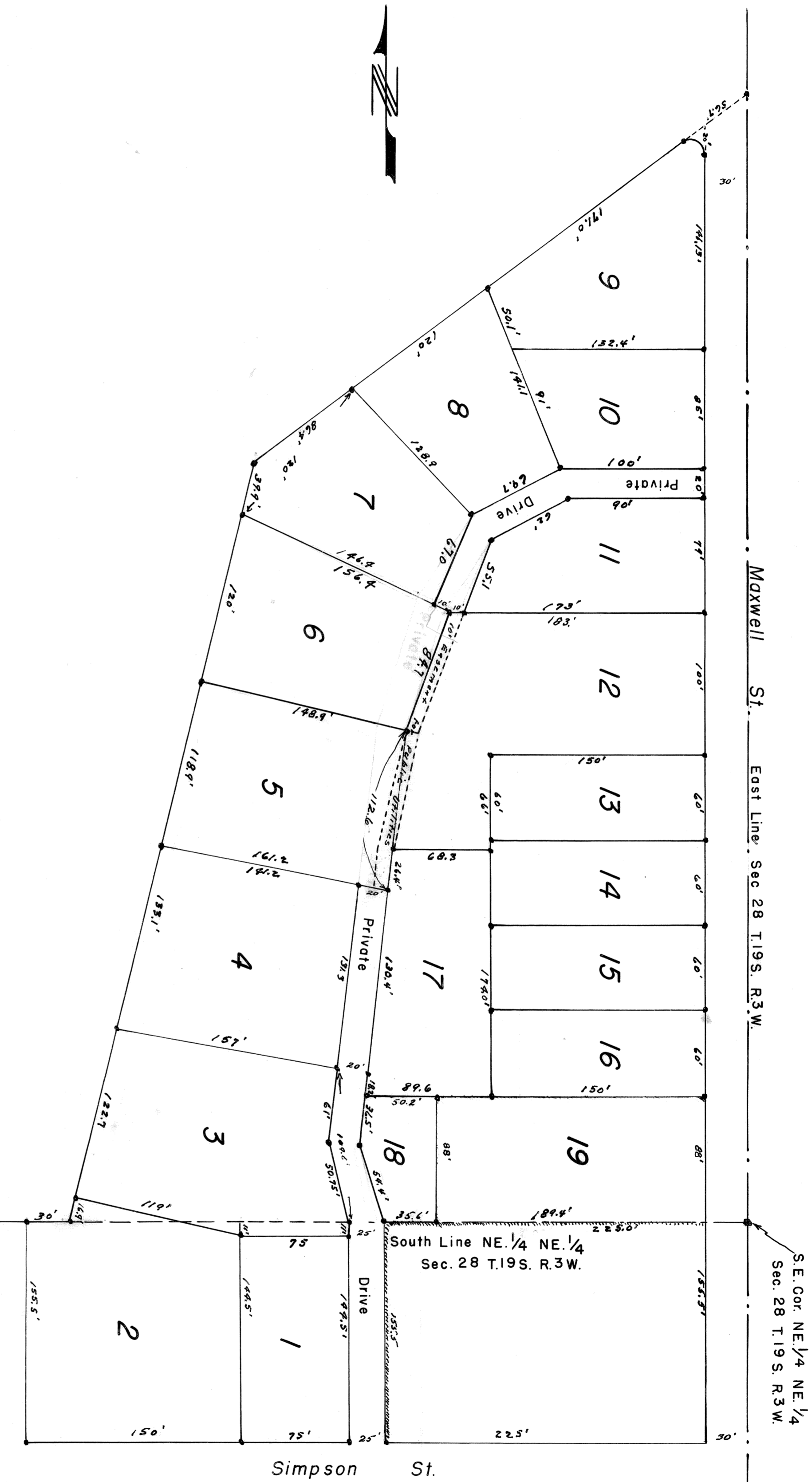


LAKESIDE PARK SUBDIVISION

Johnson, County Engineer of McPherson County, Kansas do hereby certify that I have surveyed and subdivided into lots, private drive and street the following described property located in the east half of the Northeast quarter of Section 28, Township 19 South, Range 3 West in McPherson County, Kansas to-wit:

Beginning at a point on the north line of Bass and Irwin Addition to the City of McPherson, Kansas the SE corner of the NE 1/4 of the NE 1/4, Section 28, Twp. 19 South, Rng 3 West 6th P.M. thence west along the north line of said Bass and Irwin Addition to the east line of City Park thence northeasterly along said east line of said City Park a distance of 550 feet to point 383 feet west and 534 feet north of said SE corner of said NE 1/4 of NE 1/4 of said Section 28, thence northeasterly 434 feet to a point on the east line of said Section 28 and 796 feet north of said SE corner of said NE 1/4, NE 1/4 of said Section 28, thence south along said east line of said Section 28 a distance of 796 feet

to the place of beginning, Also lots 10 to 19 inclusive of Block 1, Bass and Irwin Addition to the City of McPherson, Kansas.
