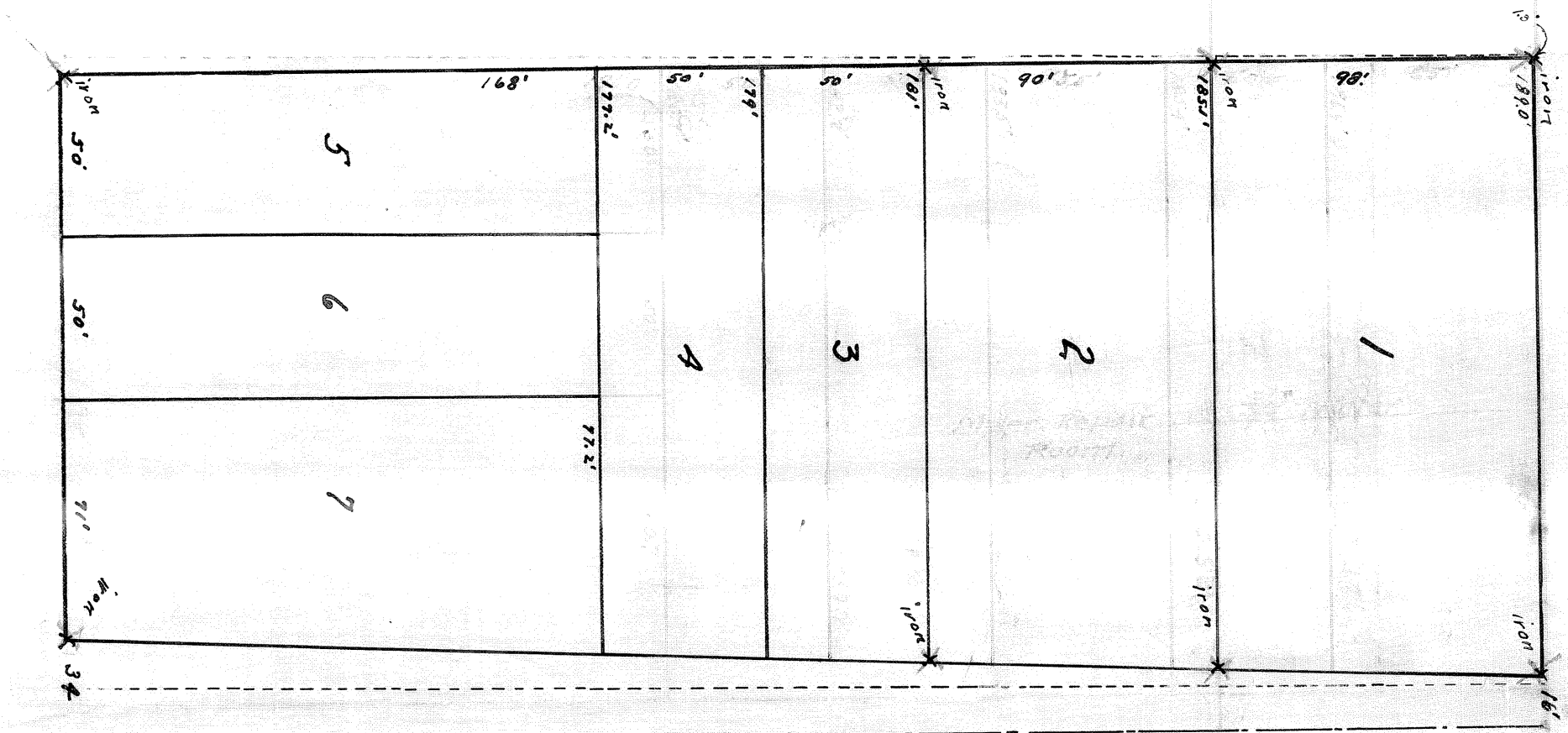


LINDBERG ADDITION LINDSBORG, KANSAS.

I, G. D. Johnson, a civil engineer of said State and county, do hereby certify, that I have surveyed and plotted Lindberg Addition to the City of Lindberg, Kansas. Said Addition is located in the Southwest Quarter of the Northwest Quarter of Section 17, Twp. 17, So. Rng. 3, West and described as follows: Tract No. 1, Beginning forty seven (47) feet west of the northwest corner of Lot 17 in West Addition to the City of Lindberg, thence south Ninety Eight (98) feet thence west One Hundred Ninety Five (195) feet, thence north Ninety Eight (98) feet, thence east One Hundred Ninety Five (195) feet to the place of beginning. Tract No. 2, Beginning forty Seven (47) feet, west of the southwest corner of Lot 21, in West Addition of Lindberg, thence north Fifty Two (52) feet, thence West One Hundred Ninety Five (195) feet, thence south Ninety (90) feet, thence east One Hundred Ninety Five (195) feet, thence north Thirty Eight (38) feet to the place of beginning. Tract No. 3, Beginning forty Seven (47) feet west and Thirty Eight (38) feet south of the southwest corner of Lot 21 in West Addition of Lindberg, thence west One Hundred Eighty One (180) feet, thence south Two Hundred Sixty Eight (268) feet, thence east One Hundred Seventy One (171) feet, thence north Two Hundred Sixty Eight (268) feet to the place of beginning. Said Addition is divided into lots, portions of Alley and streets as shown on accompanying plat. Lot No. 1, owned by C.O. Lindberg, is property described in Tract No. 1. Lot No. 2, owned by Jennie Osterberg, is property described in Tract No. 2. Lots Nos. 3, 4, 5, 6, 7 owned by C.O. Lindberg are property described in Tract No. 3.
