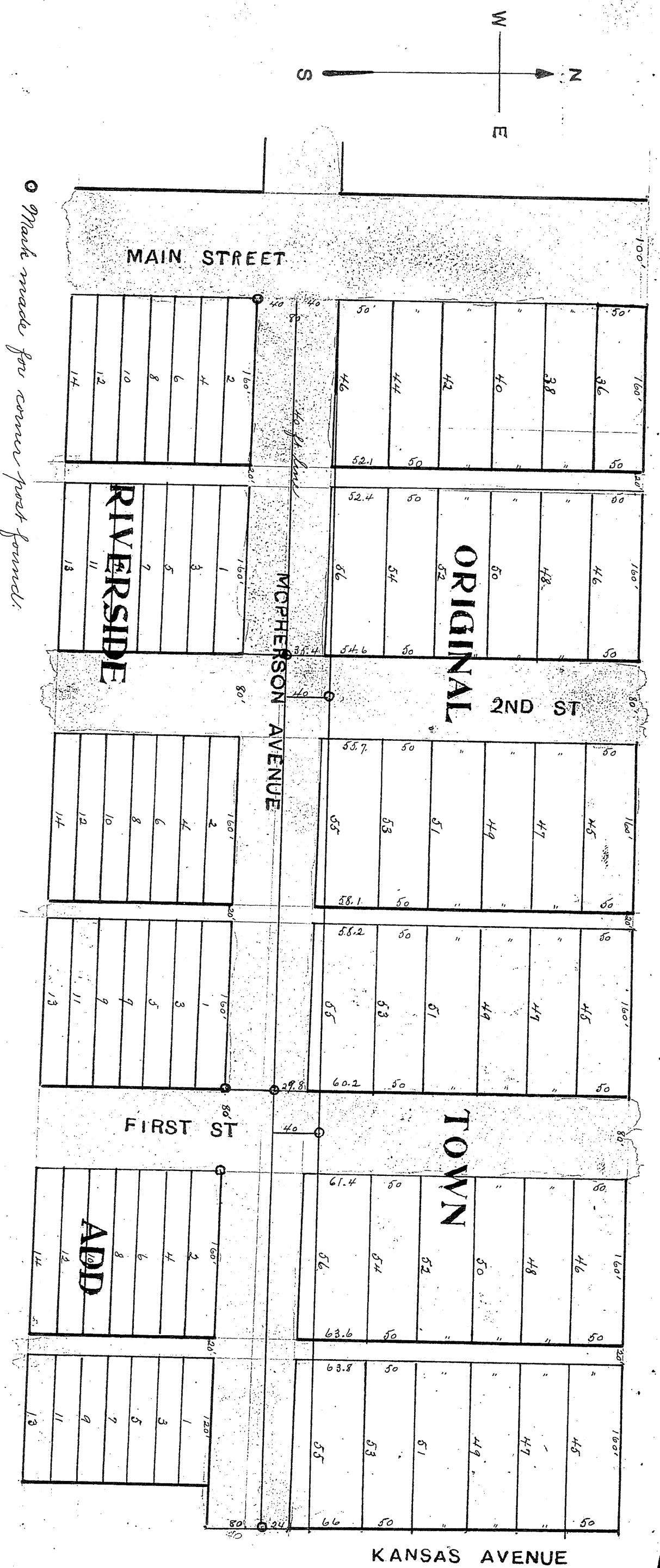


Supplemental Plat

This is to certify that J. W. A. Rowland, County Surveyor of McPherson County, Kansas, has surveyed East McPherson Street, Lindsborg, Kansas, in accordance with the following plat for the purpose of making said street 80 feet wide throughout placing the same frontage existing on the adjoining lots as shown on the following plat. All lots are as frontage 100 feet long but the width instead of being 50 feet as before are now as follows: Lot No. 49, Main Street is 50 feet across the West end and 52.1 feet across the East end; Lot No. 58, Second Street is 51.7 feet across the West end and 58.1 feet across the East end; Lot No. 55, Third Street is 53.2 feet across the West end and 60.2 feet across the East end; Lot No. 56, Main Street is 50 feet across the West end and 61.4 feet across the East end; Lot No. 57, Main Street is 50 feet across the West end and 63.6 feet across the East end; Lot No. 58, Second Street is 51.7 feet across the West end and 58.1 feet across the East end; Lot No. 55, Third Street is 53.2 feet across the West end and 60.2 feet across the East end; Lot No. 56, Main Street is 50 feet across the West end and 61.4 feet across the East end; Lot No. 57, Main Street is 50 feet across the West end and 63.6 feet across the East end.
