Explanations

McAlister's first addition is situated on Section 21 Tp. 19. R. 1 W. The initial point is the corner stone situated at the N.W. corner of Block 4 Plat of Canton. Scale 100 ft. to the inch Kansas Avenue is 80 ft wide McPherson St. is 80 ft. wide. All other streets are 60 ft. wide. Alleys are all 16 ft wide. The lots in Blocks 1, 2, 3, 4, 5, 6, 7, and 8 are 48 by 132. Lots in Blocks 9 and 10 fronting on R.R. St. are 35 by 116 all the rest in Blocks 9 & 10 are 48 by 132. All in Blocks 11 and 12 are 32 by 132.
