6TH PRINCIPAL MERIDIAN IN McPHERSON, McPHERSON COUNTY, KANSAS.

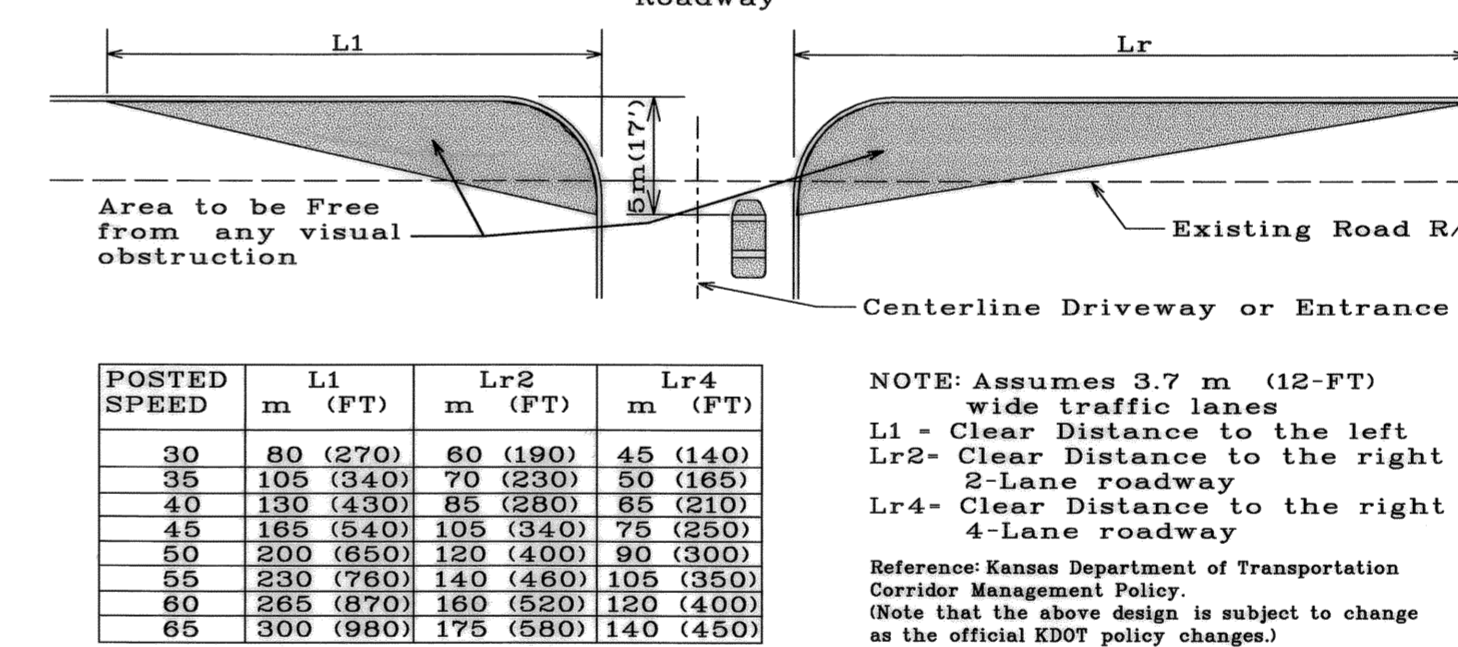
GENERAL NOTES

- ACCESS CONTROL:** All frontages along the roads shown on this plat are subject to full access control. No new entrances to any of the following roadways will be granted except by direct action of the Governing Body having jurisdiction. This restriction shall apply for Avenue A, Kiowa Road, Iron Horse Road, Hiawatha Road, 12th Avenue, 13th Avenue, and K-153 Highway.
- USE RESTRICTION - IRON HORSE ROAD:** Iron Horse Road shall be open as a public way from 12th Avenue, east to the barricades approximately 690 feet east of the SW Corner of the SE 1/4 of Sec. 31, T19S, R3W. From that point east to K-153 Highway, the right-of-way will be maintained for public utility use only.
- SIDEWALKS:** All roadways within this plat are subject to inclusion within the City Sidewalk Plan of the City of McPherson. Sidewalks shall be constructed when, where, and in the manner required by the City Commission of the City of McPherson.
- Other building restrictions apply for property within and surrounding the McPherson City/County Airport. Refer to the currently adopted version of the Airport Master Plan for the McPherson Airport on file in the office of the City Engineer, City Public Works Department, City of McPherson, Kansas.
- According to Flood Insurance Rate Map No. 200217 0015 D (dated March 16, 1983) published by the Federal Emergency Management Agency, a portion of the above described property lies within Flood Zone A which is defined as "areas of 100-year flood; base flood elevations and flood hazard factors not determined." This zone is shown on the accompanying drawing as a shaded area.

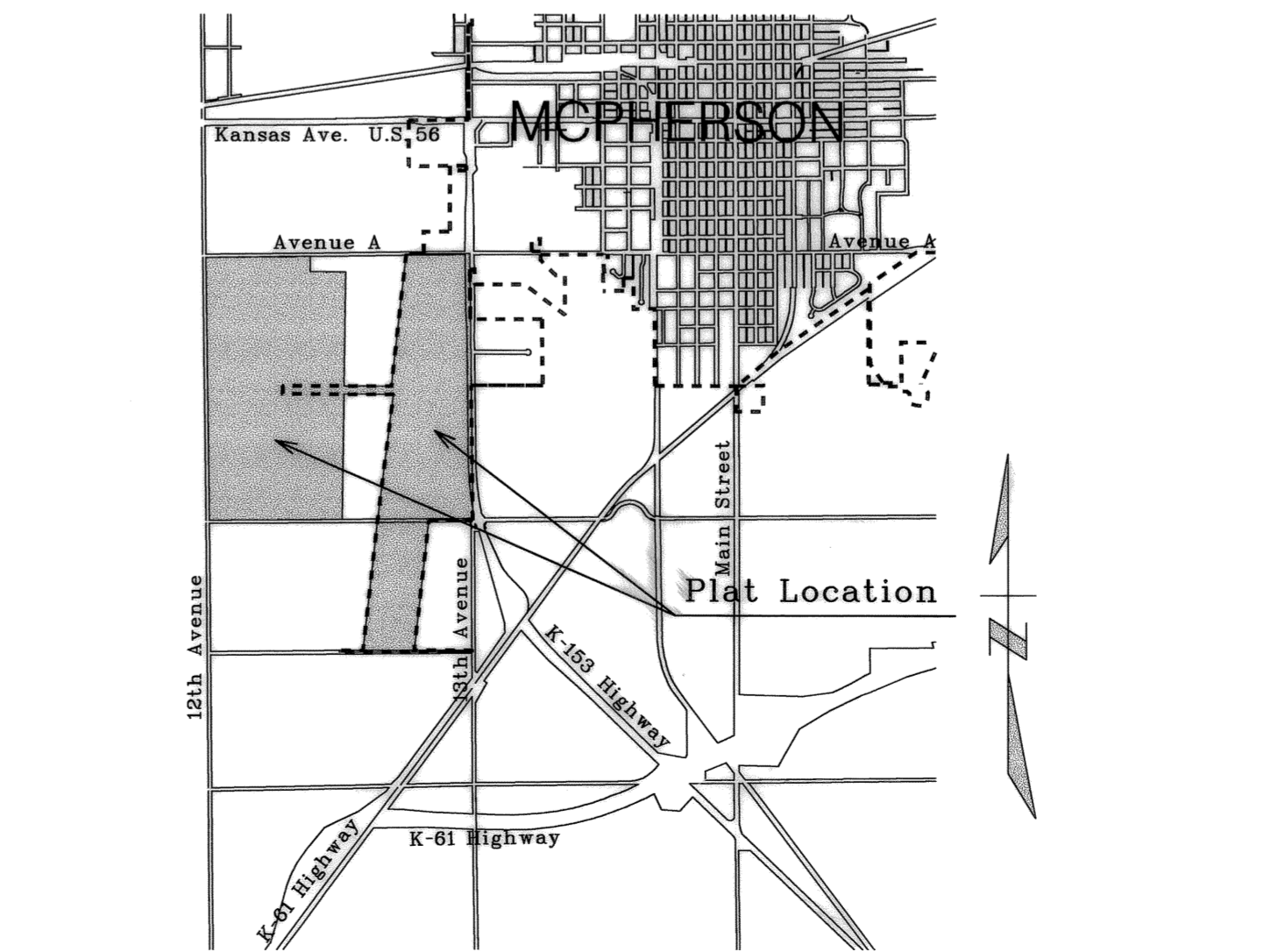

- (Misc. Bk. 140 Pg. 345-349) Right of Way to SECURITY UNDERGROUND STORAGE, INC. a Texas corporation, over the Southeast Quarter (SE/4) of Section Thirty-one (31), Township Nineteen (19) South, Range Three (3) West (Blanket Easement is NOT Plotted Hereon)

VISIBILITY TRIANGLE FOR DRIVEWAYS AND ENTRANCES

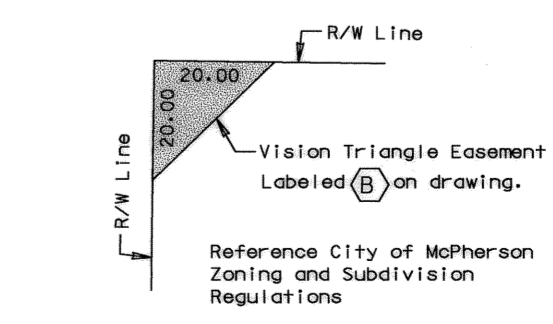
