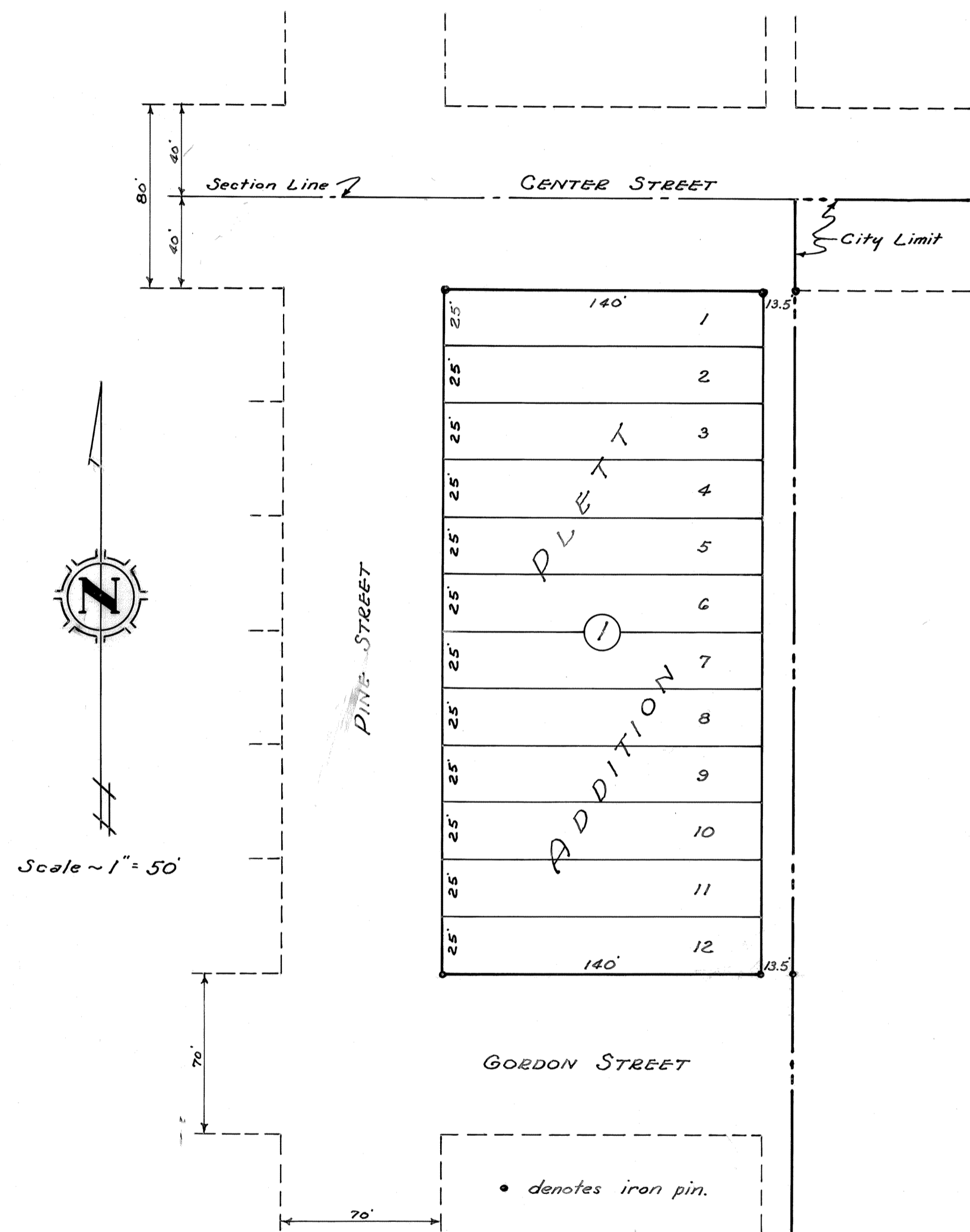


# PLETT ADDITION

## TO THE CITY OF INMAN, KANSAS

I, O.O. Ediger, Consulting Engineer, in and for said County and State, do hereby certify that I have surveyed and platted Plett Addition to the City of Inman, Kansas, and that the accompanying plat is a true and correct exhibit of the property as surveyed, described as follows: Beginning at a point one thousand one hundred seventy two (1,172) feet east of the northwest corner of Section 16, Township 21 South, Range 4 West of the Sixth Principal Meridian, in McPherson County, Kansas, thence east one hundred fifty three and one-half (153.5) feet, thence south three hundred forty (340) feet, thence west one hundred fifty three and one-half (153.5) feet, and thence north three hundred forty (340) feet to point of beginning, all lying in Section 16, Township 21 South, Range 4 West of the Sixth Principal Meridian, in McPherson County, Kansas.

All property corners are marked with iron pins.
