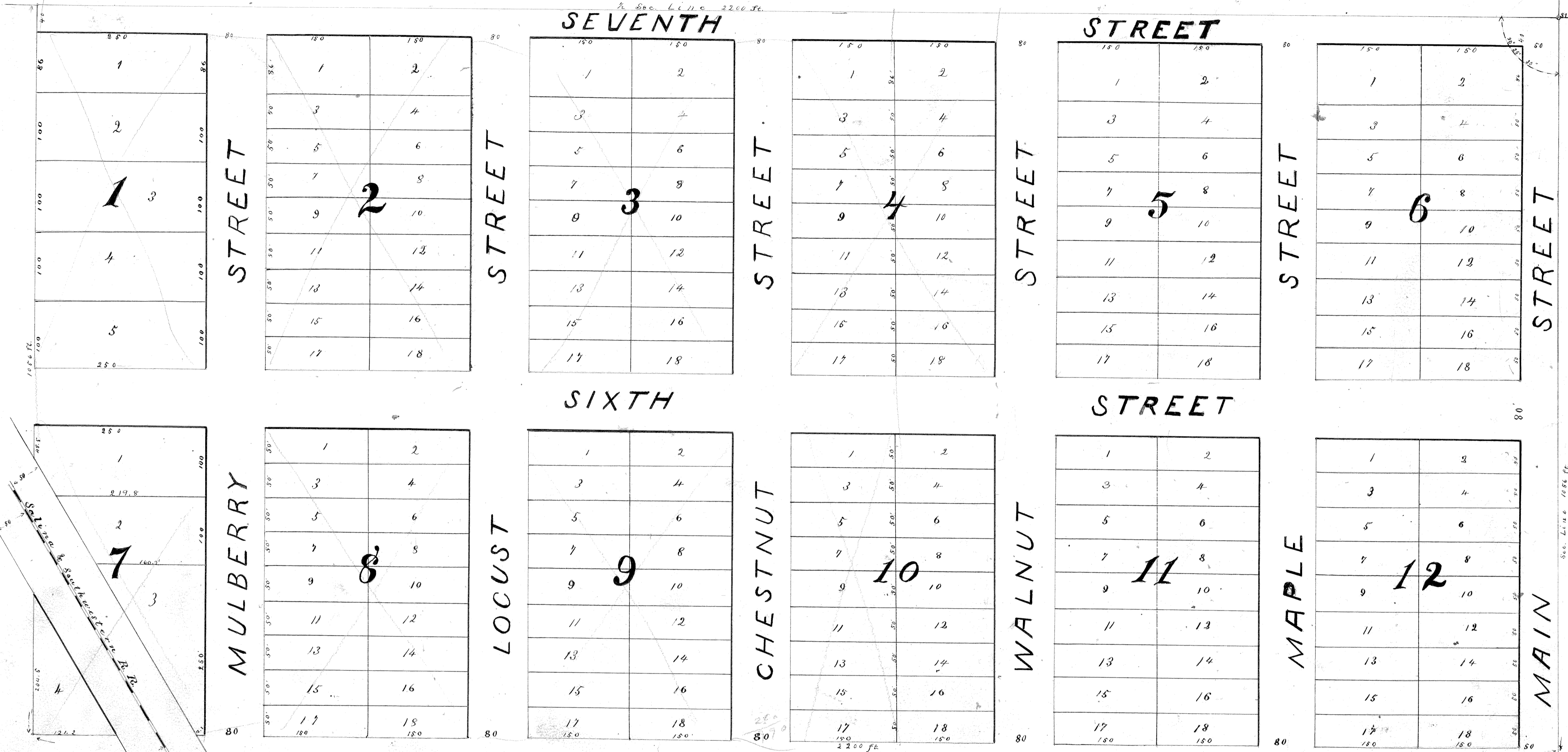


# PLAT OF PROSPECT ADDITION

Know all men by these presents: - That we J. M. Hamilton, F. C. York, pro. D. Milliken and F. E. Barber being the owner and proprietors of the tract of land hereinafter described have caused to be surveyed and platted the following described tract of land as and for an addition to the City of McPherson Kan. Commencing at the North East corner of the South East Quarter of Section Twenty Six Township Nineteen South and Range Three West of the Sixth principal meridian in McPherson Co. State of Kansas. Thence South along the East line of said Section one thousand and fifty six (1056) feet Thence West and parallel with the North line of said quarter section twenty two hundred (2200) feet Thence South one thousand and fifty six (1056) feet to the South line of said quarter section. Thence East along said quarter section line twenty two hundred (2200) feet to the place of beginning, deducting there from the right of way of the Salina and South Western Railway, described by the following notes and bounds, being a strip of land one hundred feet wide. The center line of which is one hundred and seventy nine and five tenths (179.5) feet and three hundred and three (303) feet respectively from the South west corner of the tract hereinafter described leaving fifty two and fifty two hundredths (52.52) acres as surveyed and platted for addition. We hereby publish and declare that all of the ground within the limits aforesaid reserved for public uses, and intended for Avenues & Streets are described and indicated by their courses and names and are measured in feet by figures on said map respectively and therein particularly set forth and described in their exact boundaries courses and extent. And that the dimensions of lots in said Addition are of the precise length and width in feet as shown in numbers & figures. We hereby further certify that the map herewith with its Streets & Subdivisions of whatever nature as indicated thereon is a true and correct representation of the facts herein set forth. We hereby declare that the name of the Addition is Prospect Addition to the City of McPherson Kan.
