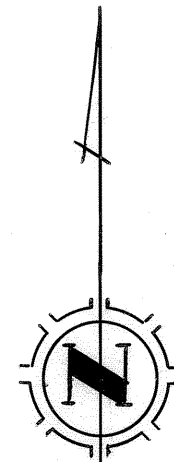
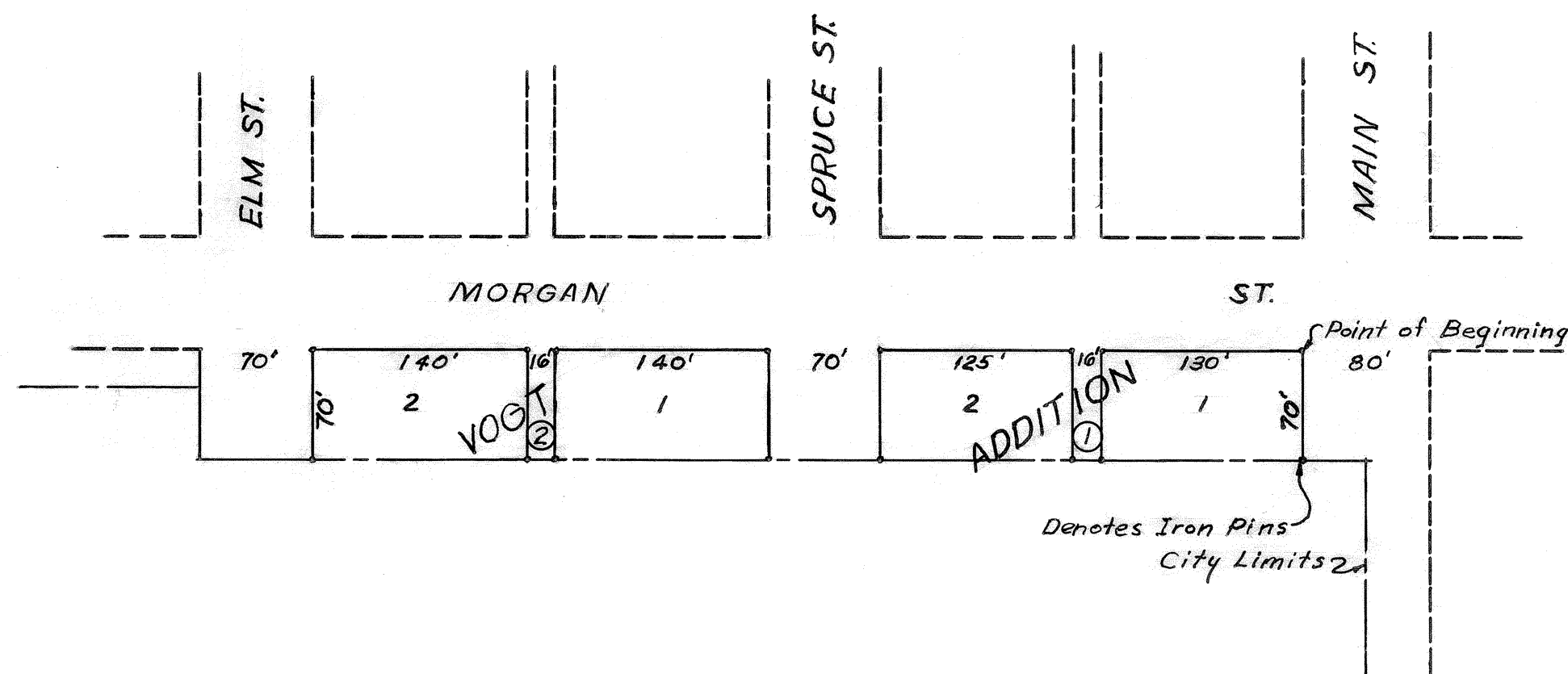


PLAT OF VOGT ADDITION TO THE CITY OF INMAN, KANSAS



Scale: 1"=100'

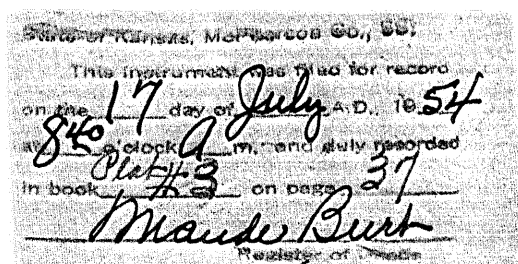
