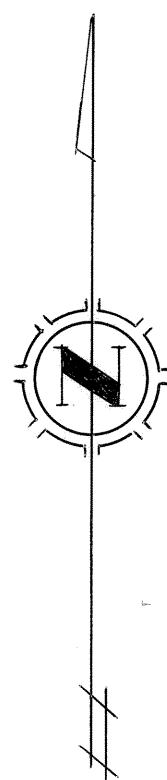
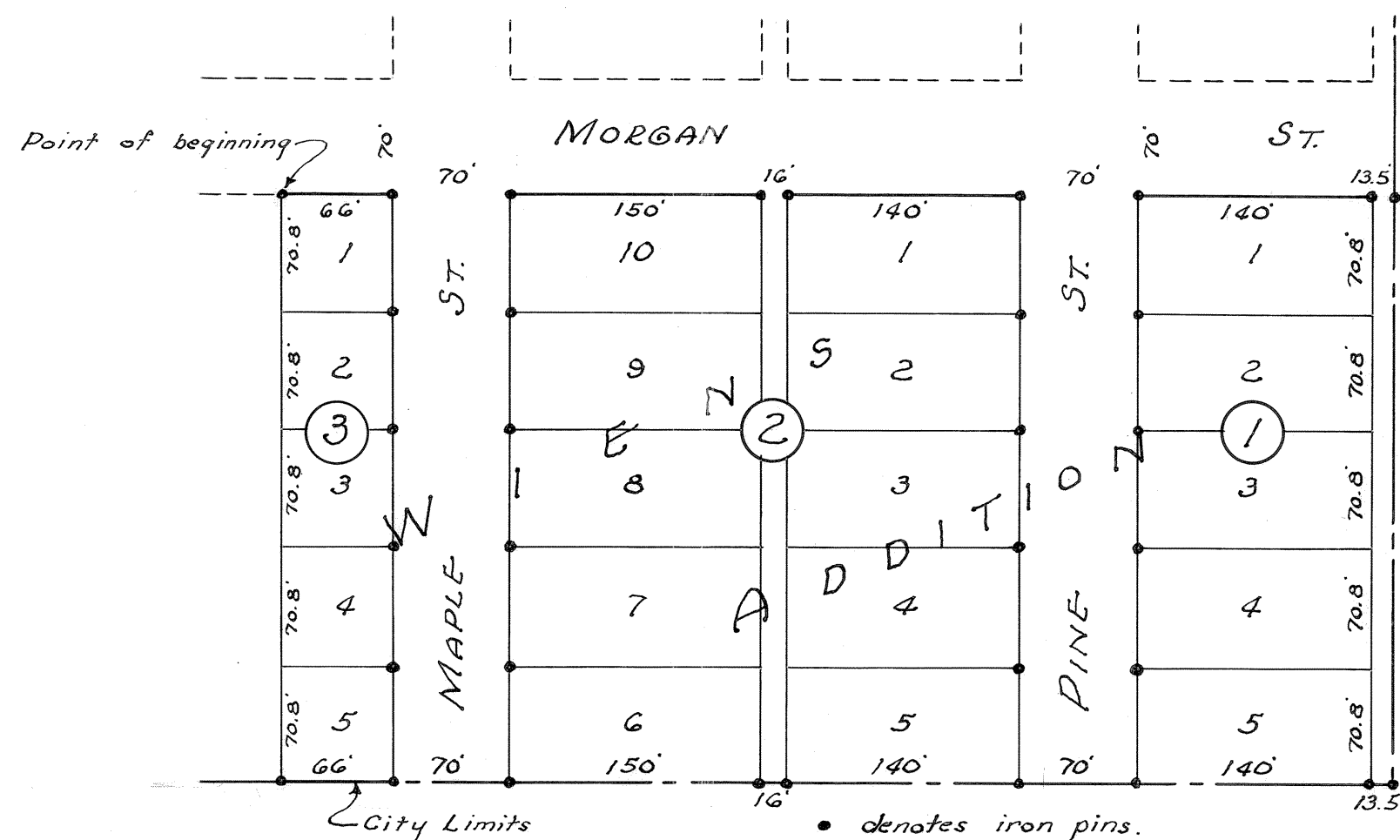

Scale ~ 1" = 100'



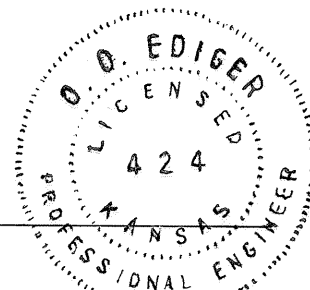

I, O.O. Ediger, Consulting Engineer, in and for said County and State, do hereby certify that I have surveyed and platted Wiens Addition to the City of Inman, Kansas, and that the accompanying plat is a true and correct exhibit of the property as surveyed, part of the Northwest Quarter (NW $\frac{1}{4}$) of Section 16, Township 21 South, Range 4 West of the Sixth Principal Meridian, in McPherson County, Kansas, described as follows: Beginning at a point one thousand three hundred (1,300) feet south and six hundred sixty (660) feet east of the northwest corner of said Northwest Quarter (NW $\frac{1}{4}$) of Section 16, thence east six hundred sixty five and one-half (665.5) feet, thence south three hundred fifty four (354) feet, thence west six hundred sixty five and one-half (665.5) feet, thence north three hundred fifty four (354) feet to point of beginning, all lying in Section 16, Township 21 South, Range 4 West of the Sixth Principal Meridian, in McPherson County, Kansas.

All property corners are marked with iron pins.
