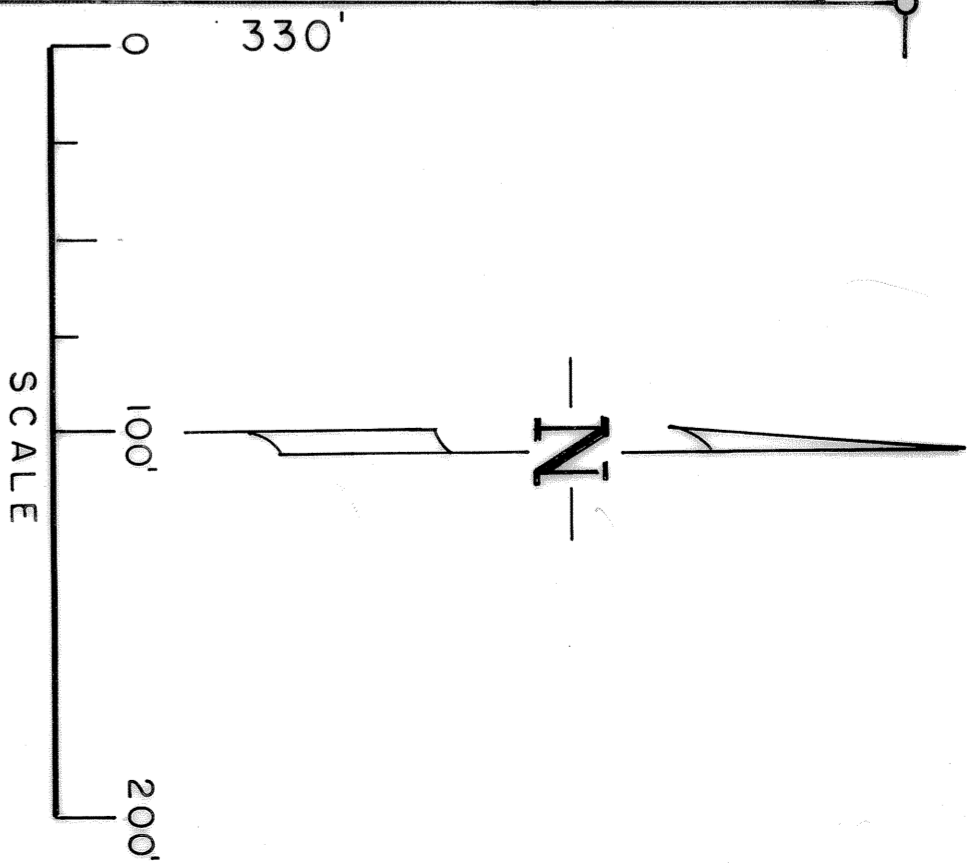
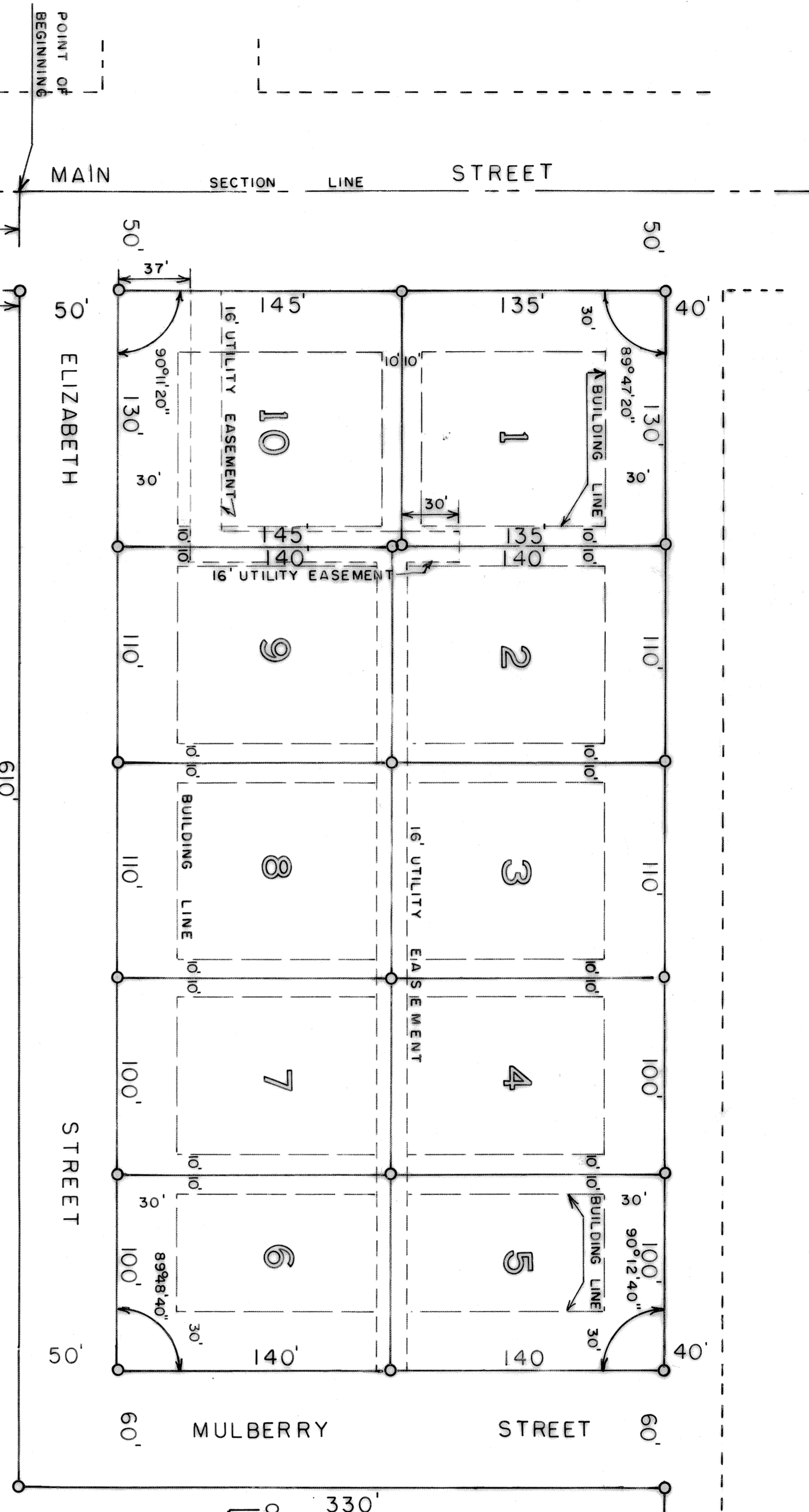

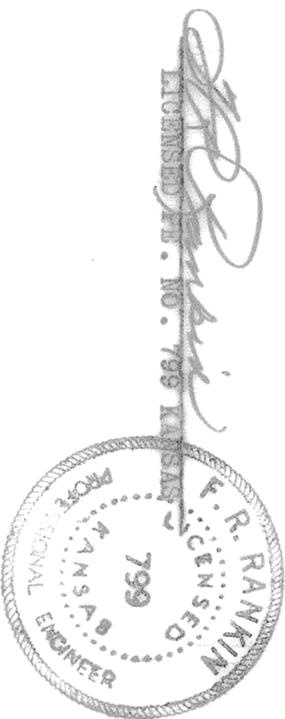
SURVEYING CERTIFICATE AND DESCRIPTION

I, FRANCIS BANKER, A LICENSED PROFESSIONAL ENGINEER OF THE STATE OF KANSAS, CERTIFY THAT I HAVE SURVEYED, OR CAUSED A SURVEY TO BE MADE UNDER MY SUPERVISION, OF THE ABOVE PLAT AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER (SW 1/4) OF SECTION 22, TOWNSHIP 19 SOUTH, RANGE 2 WEST OF THE 6th P.M.; THENCE NORTH ON SECTION LINE 321.7 FEET TO POINT OF BEGINNING, BEING THE NORTH RIGHT CORNER OF THE ROCK ISLAND RAILROAD WHICH IS 200 FEET NORTH OF THE CENTER-LINE OF SAID RAILROAD TRACKS; THENCE EAST ALONG RAILROAD RIGHT OF WAY 600 FEET; THENCE NORTH 830 FEET; THENCE WEST TO SECTION LINE 600 FEET; THENCE SOUTH 300 FEET TO PLACE OF BEGINNING.

FRANCIS WILLIAMS OWNERS AND PROPRIETORS OF THE LANDS DESCRIBED IN THE CERTIFICATE OF SURVEYOR, HAVE CAUSED THE SAID LANDS TO BE SURVEYED INTO LOTS AND UNDER THE NAME OF WILLIAM'S ADDITION, TO THE CITY OF GALVA, KANSAS, AND HAVE CAUSED THE SAME TO BE SUBDIVIDED INTO LOTS, STREETS, AVENUES AND PUBLIC WAYS, AS SHOWN ON THE ACCOMPANYING PLAT, AND FURTHER THAT ALL STREETS, ALLEYS AND PUBLIC WAYS ARE FOR THE USE OF THE PUBLIC. THE SAID WILLIAMS' ADDITION, AND THE LAND CONTAINED THEREIN, IS HEREY AND SHALL BE CONVEYED SUBJECT TO THE RESERVATIONS AND RESTRICTIONS AND COVENANTS AS FOLLOWS:

1. THE USE OF THE LOTS AS RECORD HEREIN SHALL BE ONLY FOR NEW 5 NILE SINGLE OR ATTACHED GARAGE.
2. THAT ONLY ONE OFF BUILDING SHALL BE ALLOWED ON EACH LOT AND IT SHALL NOT EXCEED 150 SQUARE FEET.
3. THERE SHALL BE NO LIVESTOCK OR POLICRY RAISED.
4. ALL ORDINANCES OF THE CITY OF GALVA SHALL RELATE TO THIS PROPERTY.

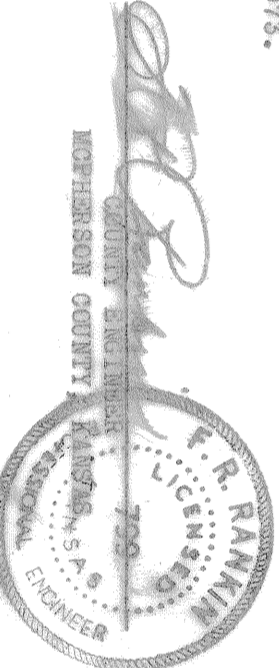

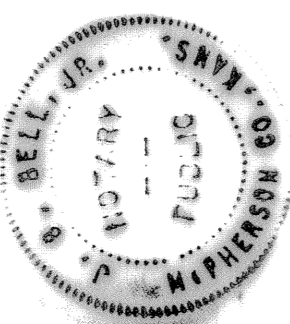
